TWO WAY WORKING FOR PEDAL CYCLES IN CERTAIN STREETS

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London on 4 December 2009, made an order under section 6 of the Road Traffic Regulation Act 1984.

2. The effect of the order will be to :

(a) permit pedal cycles to proceed in both directions in the streets and lengths of streets specified in the Schedule to this Notice; and
(b) restore two way working for all vehicles in Fann Street, between Viscount Street and Golden Lane.

3. A copy of the order, which will come into operation on 14 December 2009 and of plans showing the affected streets, can be inspected during normal office hours on Monday to Fridays inclusive until the end of six weeks from the date on which the order was made at the Department of Planning and Transportation, Guildhall, London, EC2P 2EJ.

5. Any person desiring to question the validity of the order or of any provision contained therein on the ground that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within six weeks from the date on which the order was made, make application for the purpose to the High Court.

ROAD TRAFFIC REGULATION ACT 1984

THE A580 TRUNK ROAD (HAYDOCK ISLAND CIRCULATORY CARRIAGEWAY) (40 MILES PER HOUR SPEED LIMIT) ORDER 20**

NOTICE IS HEREBY GIVEN that the Secretary of State for Transport proposes to make an Order under Sections 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 on a section of the A580 Trunk Road in the District of St Helens in Merseyside, which forms the circulatory carriageway at Haydock Island (M6 Motorway Junction 23).

The Order, if made, will impose a 40 miles per hour speed restriction on the circulatory carriageway of the A580 at Haydock Island, and on the eastbound and westbound through carriageways of the A580, which run through the centre of the circulatory carriageway.

The speed restriction will not apply to vehicles being used for emergency purposes by the police, fire and rescue or ambulance services.

THE A580 TRUNK ROAD (HAYDOCK ISLAND CIRCULATORY CARRIAGEWAY) (PROHIBITION OF RIGHT TURNS) ORDER 20**

NOTICE IS HEREBY GIVEN that the Secretary of State for Transport gives notice that he proposes to make an Order under Sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984 on a section of the A580 Trunk Road in the District of St Helens in Merseyside, which forms the circulatory carriageway at Haydock Island (M6 Motorway Junction 23).

The Order if made will prohibit any motor vehicles (except those being used for emergency purposes by the police, fire and rescue authority, ambulance services or traffic officers) from making right turns into —

(a) the eastbound through carriageway of the A580 from the west side of the circulatory carriageway; and
(b) the westbound through carriageway of the A580 from the east side of the circulatory carriageway.

Traffic wishing to make these right turns will continue around the circulatory carriageway to the exits from the roundabout leading to the A580 eastbound or westbound.

THE GREENWICH (PROHIBITION OF STOPPING OUTSIDE SCHOOLS) (AMENDMENT NO. 17) ORDER 2009

1. NOTICE IS HEREBY GIVEN that Greenwich Borough Council on 7th December 2009 made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Order will come into operation on 10th December 2009.
