THE GREENWICH (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 22) ORDER 2009

THE GREENWICH (FREE PARKING PLACES) (DISABLED PERSONS) (AMENDMENT NO. 16) ORDER 2009

1. NOTICE IS HEREBY GIVEN that Greenwich Borough Council on 7th December 2009 made the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Orders will come into operation on 10th December 2009.

2. The general effect of the Orders will be to:

- (a) introduce double yellow line "at any time" waiting restrictions at the junction of **Courtlands Avenue** and **Fairby Road**;
- (b) extend the existing double yellow line "at any time" waiting restrictions on the north-east side of **Mottingham Road** for a further 10 metres north-west from its junction with Leysdown Road (for a total length of 20 metres north-west of that junction);
- (c) formalise the existing double yellow line "at any time" waiting restriction markings on **Weigall Road** which extend for approximately 28 metres east of the entrance to the David Lloyd leisure centre; and
- (d) create disabled persons' parking places of 6 metres in length in which vehicles displaying a valid disabled person's "Blue Badge" may be left at any time, without charge and without time limit at the following locations:

- (i) outside No. 13 **Legatt Road**; and
- (ii) outside No. 270 **Westhorpe Avenue** (on the footway).

3. The Council has deferred a decision on the proposals to introduce double yellow line "at any time" waiting restrictions on the south-east side of Kingsground (opposite Queenscroft Road) and at the junction of Weigall Road and Lyme Farm Road while it considers representations to those proposals.
