An Act for repealing an Act made in the ninth Tear of the Reign of Her lave Majely Queen Anne, Intituled, An Act to oblige Ships coming from Places infeeted, more effectually to perform their Quarentine; and for the better presenting the Pizgue being brought from fo eign Parts into Great Britain or Ireland, or the lft s of Guernscy, Jersey, Alderney, Sark or Man; and to binder the spreading of Insection.

Hereas in the Parliament begun and holden at Westminster in the ninth Year of the Reign of her I te Majesty Queen Anne, an Act passed, in tituled, An Act to oblige Skips coming from Places in co. 1, more effectually to perform the ir Q a centine; and whereas Marseilles, and other Places in the Southern Parts of France, have, for some time past, been visited with the Plague, which o caloned just Apprehensions left the Infection might be brought into this Kingdom from the Places to infected, or other Places trading or corresponding therewith, unless tim ly Care were t ke i to prevent the same; and w ieleas it has been found by Experience, that the said Act is defective and insufficient for the Purpos s intended; and the Penalties inflicted by the fame not adequate to the Offences thereby prohibited; and some furth r Provisions are necessary to be made, in case it hould please Almighty God to p-rmit these Kingdoms to be affilded with the Plague: For Remedy thereof, be it enacted by the King's most excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons in Parliament af-fembled, and by the Authority of the fame, that during the present Insection, and in all suture Times, when any Country or Place shall be in-fected with the Plague, all Ships, Vessels, Persons, Goods and Merchandizes whatfoever, coming or imported in fuch Ships or Vessels, into any Port or Place within Great Britain or Ireland, or the Ifles of Guernsey, Jersey, Alderney, Sark or Man, from any Place to infected, or from any Place the Inhabitants whereof are known to trade or correspond with any Country or Place actually infected, or from any Place from whence his Majesty, his Heirs or Successors, by and with the Advice of his or their Privy-Council, shall induce it probable that the Lofe Place may be judge it probable that the Infection may be brought, shall be obliged to make their Quarentine in such Place and Places, for such Time and in such Manner as hath been or shall, from time to time, be directed by His Majesty, his Heirs or Successors, by his or their Order or Orders made in his or their Privy Council, and notified by Proclamation; and that until fuch Ships, Vef-fels, Persons, Goods, and Merchandizes, shall have respectively performed, and be discharged from such Quarentine, no such Persons, Goods, or Merchandizes, or any of them, shall come or be brought on Shore, or go or be put on board any other Ship or Vessel in any Place within His Majesty's Domi-nions, unless in such Cases, and by such proper Licence, as shall be directed or permitted by such Order or Orders made by His Majesty, his Heirs or Successors, in Council, and notified, as aforesaid; and that all such Ships and Vessels, and the Perfons and Goods coming or imported in, or go-ing or being put on board the same, and all Ships, Vessels, Boats, and Persons receiving any Goods or Persons out of the same, shall be subject to such Orders, Rules, and Directions concerning Quaentine, and the prevention of Infection, as have been or shall be made by His Majesty, his Heirs and Successions, in Council, and notified by Proclamations, as aforesaid.

performed, shall go off, or cause some other Per-son to be by him appointed for that Purpose, to go off to such Ship or Vessel; and such Officer or other Person authorized to see Quarentine performed, as aforefaid, or the Person so by him ap-pointed for that Purpose, shall, at a convenient Distance from such Ship or Vessel, demand of the Commander, Master, or other Person having Charge of fuch Ship or Vessel, and such Commander, Mafter, or other Person having Charge of such Ship or Vessel, shall, upon such Demand, give a true Account of the following Particulars; (that is to say) the Name of such Ship or Vessel; the Name of the Commander or the Person having Charge thereof; at what Place the Cargo was taken on board; what Place or Places the Ship or Vessel touched at in her Voyage; Whether such Places, or any, and which of them, were infected with the Plague; how long fuch Ship or Vessel had been in her Passage; how many Persons were on board when the said Ship or Vessel set Sail; whether any, and what Persons, during that Voyage, on board such Ship or Vessel, had been or shall be then insected with the Plague; how may died in the Voyage, and of what Distemper; what Ships or Vessels he or any of his Ships Company with his Privity went on board, or had any of their Company come on board his Ship or Vessel in the Voyage; and to what Place such Ships or Vessels belonged; and also the true Contents of his Lading to the best of his Knowredge: And in case it shall appear upon such Examination or otherwise, that any Person then on board such Ship or Vessel, shall at the time of fuch Examination be actually infected with the Plague, in such case it shall and may be lawful to and for the Officers of any of His Majesty's Ships of War, or any of His War, o ity's Forts or Garrisons, and all other His Majefly's Officers, whom it may concern, upon Notice thereof given to them, or any of them re-spectively, and to and for any other Person or Perfons, whom they shall call to their Aid or Affistance, and they are hereby required to resist and oppose the Entrance of such Ship or Vessel into any such Port or Place, or to oblige such Ship or Vessel to depart out of the same, and to use all necessary Means for the Purposes aforesaid, or either of them, be it by siring of Guns upon such Ship or Vessel, or any other kind of Force and Violence whatsoever; and in case any such Ship or Vessel shall come from any Place visited with the Vellel thall come from any Place visited with the Plague, or have any Person on board actually infected, and the Commander, Master, or other Person laving Charge of such Ship or Vessel, shall not discourt the same, such Commander. Master, or oth r Person having Charge of such Ship or Vessel, thall be adjudged guilty of Felony, and suffer Death, as in case of Felony, without Benefit of Clergy, and in case such Commander, Master, or other Person having Charge of such Ship or Vessel, shall, upon such Demand made, as aforesaid, nor make ther any Ship or Vessel be actually infected with a true Discovery in any other of the Particulars the Plague, or whether such Ship or Vessel, or (Price Three Half Pence.)

That during the present Insection, and in all future Times, when any Country or Place shall be insected with the Plague, and any Order or Orders shall be made by His Majesty, his Heirs or

Successors, concerning Quarentine, and the Prevention of Infection, and notified, as aforesaid, as often as any Ship or Vessel shall attempt to en-

ter into any Port or Place in Great Britain or Ireland, or the Isles of Guernsey, Jersey, Alderney, Sark, or Man, the principal Officer of His Majesty's Customs in such Port or Place, or such Per-

ion as shall be authorized to see Quarentine duly

for every such Offence shall forfeit the Sum of two hundred Pounds; one Moiety thereof to the King, his Heirs and Successors, and the other Moiety to him or them who will fie for the same, by Action, Bill, Plaint, or Information, in any of His Majesty's Courts of Record at Westminster, Edinbuigh, Dublin, or in the proper Courts of the Isles of Guernsey, Jersey, Alderney, Sark or Man, re-

spectively.

And be it further enacted by the Authority aforefaid, That if any Commander, Master, or other Person having Charge of any Ship or Vessel liable to perform Quarentine, shall himself quit, or shall permit or fuffer any Seaman, or Passenger coming in such Ship or Vessel, to quit such Ship or Vessel. fel by going on Shore, or by going on board any other Ship, Boat, or Vellel before such Quarentine shall be duly performed, unless in Such Cases, and by fuch proper Licence as thall be directed or permitted by fuch Order or Orders made or to be made concerning Quarentine, and the Prevention of Infection, and notified, as aforesaid; or in case any Commander, Master, or other Person having Charge of such Ship or Vessel, shall not within convenient time, after due Notice given for that Purpose by the proper Officer, cause such Ship or Vessel, and the Lading, to be conveyed into the Place or Places appointed for such Ship or Vesfel, and the Lading thereof, to perform Quarentine respectively, then and in every such case, every such Ship or Vessel, with her Sackle, Apparel and Furniture, shall be forseited to His Majesty, and Furniture, shall be forfeited to His Majesty, his Heirs and Successors, and shall and may be soized, sued for, and recovered in His Majcity's Court of Exchequer at Westminster, Edinburgh, or Dublin, or in the proper Courts of the Isles of Guernsey, Jersey, Alderney, Sark, or Man respe-tively, to the Use of His Majesty, his Heirs and Succ sfors; and every such Commander, Master, or other Person, h ving Charge of such Ship or V stell, for every such Offence shall forseit the Sum of two hundred Pounds; one Moiety there-of to the King, his Heirs and Successors, and the oth 1 Moiety to him or them who will fue for the fame; and also if any Person shall so quit such Ship or Vessel by going on Shore, or by going on board any other Ship or Vessel contrary to the true Meaning of this Act, it shall and may be lawful for all Persons whatsoever, by Force and Violence, to compel such Person to return on board such Ship or Vessel; and every such Person so quitting such Ship or Vessel, shall, for every such to compel fuch Person to return on board Off nce, fuffer Imprisonment for the Space of fix Months, and shall also forfeit the Sum of two hundred Pounds; one Moiety to the King, his Heirs and Successors, the other Moiety to him or them that will fue for the fame; the same respe-Rive Penaltie and Forfeitures to be recovered by Action, Bill, Plaint, or Information in any of His Majesty's Courts of Record at Westminster, Edinburgh, or Dublin, or in the proper Courts of the Isles of Gueinsey, Jersey, Alderney, Sark, or Man respectively.

And be it further enacted by the Authority a-resaid, That if at any Time or Times hereafter any City, Town or Place within Great Britain or Ireland, or the Isles of Guernsey, Jersey, Alderney, Sark, or Man, shall be infected with the Plague, and the same, upon Examination, shall be made appear to His Majesty, his Heirs or Successors, in Council, it shall and may be lawful to and for His Majesty, his He rs and Successors, by and with the Advice of his or their Privy Council, during the Continuance of fuch Calamity, to make fuch Orders and Regulations concerning Quarentine, and the Prevention of Infection, as shall be necessary for the Sasesy and Preservation of his or their Subjects, and to notifie the same by Proclamation; and all and every Person and Persons, Officer and Officers, Civil and Military, whatso ever, shall render due and exact Obedience to all fuch Orders and Regulations fo made and noti-

fied, as aforefaid.

And be it further enacted by the Authority a-foresaid, That during the present Infection, and in all future Times, when any Country or Place shall be infected with the Plague, it shall and may be lawful to and for His Majesty, his Heirs

other Person having Charge of such Ship or Vessel, 1 and Successors, to order Ships to be provided, or to cause Houses or Lazarets for the receiving and entertaining of Persons infected with the Plague, or obliged to perform Quarentine, during fuch Time as they shall continue infected, or until they shall have performed such Quarentine re-spectively; and also Sheds, Tents, and other Places, proper for the depositing, opening, and airing of Goods and Merchandizes comprized within any such Order or Orders, made or to be made and notified, as aforesaid, to be provided or erected, to continue for such Time and Term as His Majesty, his Heirs and Successors, shall think proper and direct, in convenient Places within any Part of Great Britain or Ireland, to be allowed and approved by two or more Justices of the Peace for the County, Division, or Liberty, where the same shall respectively lie, living near thereumo, under their Hands and Seals, either in any Waste Grounds or Commons, or where such Waste Grounds or Commons are not sufficient, in the feveral Grounds of any Perion or Perions whatsoever, not being a House, Park, Garden, Orchard, Yard, or planted Walk, or Avenue to a House, paying such Rate, Rent, or Consideration for the same to the Persons interested therein respectively, according to their several Interests in as shall be agreed upon between the Persons so interested, their Guardians or Trustees, and any two Persons to be appointed for that Purpose by His Majesty, his Heirs or Succes-fors, under his or their Sign-Manual; and in case of any Difference concerning such Rate, Rent, or Confideration, between the Persons so interested, their Guardians or Trustees, and such Persons so to be appointed by His Majesty, his Heirs or Successors, as aforesaid, the Justices of the Peace at the next General Quarter Sessions of the Peace to be held for such County, Division, or Liberty, wherein such Grounds shall lie, shall and may adjudge, determine, assess, and settle the same, and such Judgment and Determination shall be sinal; and his Majesty, his Heirs and Successors, shall and may hold and enjoy such Ground, for and during all such Time and Term as His Majesty, his Heirs or Successors, shall judge necessary for the Purposes aforesaid, paying for the same such Rate, Rent, or other Consideration, as shall be agreed upon, or assessed and adjudged, as aforesaid.

And be it further enacted by the Authority aforefaid, that the proper Officers authorized to put in Execution fuch Orders, nade or to be made and notified, as aforefaid, first and they are hereby impowered and required to cause and compel all Persons insected with the Plague, or obliged to person Quarentine, and all Goods and Merchandizes comprized within any fuch Orders, made or to be made and notified, as aforefaid, respectively, to repair or be conveyed to some of the said Ships, Houses, or Lazarets, Sheds, Tents, or other Places, provided, as aforesaid, according to fuch Order or Orders, made or to be

made and notified, as aforesaid.

And be it further enacted, That if any Person insected with the Plague, or obliged to perform Quarentine, shall wilfully resuse or neglect to repair within convenient time, after due Notice for that Purpose given to him, her, or them, by the proper Officer, to the Ship, House, Lazaret, or other Place duly appointed for him, her, or them; or having been placed in such Ship, House, Lazaret, or other Place, shall escape, or attempt to escape out of the same, whilst he, she, or they shall continue infected, or before Quarentine fully performed respectively; it shall and may be lawful to and for the Warchmen and other Persons, appointed to see Quarentine per-formed, by any kind of Violence that the Case shall require, to compel every such Person so refuling or neglecting, as aforesaid, and every such Person so escaping, or attempting to escape, as aforesaid, to repair or return into such Ship, House, Lazaret, or other Place, so appointed for him, or her, as aforefuld; and every fuch Perfon fo refuling or neglecting to repair within convenient time after such Notice, as aforesaid, in-to such Ship, House, Lazaret, or other Place ap-pointed for him, or her, as aforesaid, and also every Person astually escaping, as aforesaid, shall be adjudged guilty of Felony, and finall fuffer l

Death as a Felon without Benefit of Clergy.

And be it further enacted, That if any Person not infected, nor liable to persorm Quarentine, shall presume to enter any Ship. House, Lagaret, or other Place so appointed, as afores id, whilst any Person or Persons so infected, or being under Quarentine, shall be therein, and shall return, or attempt to return from thence, unless in such Cases, and by such proper Licence, as shall be directed or permitted by such Order or Orders, made or to be made and notified, as assoresaid, it shall and may be lawful to and for the Watchmen, or other Persons appointed to guard or secure such Ship, House, Lazaret, or other Place so appointed, as assoresaid, by any kind of Violence that the Case shall require, to compel such Person, so returning, or attempting to return, to repair into some Ship, House, Lazaret, or other Place, so appointed, as aforesaid, there to continue and personm Quarentine; and in case such Person shall astually escape out of such Ship, House, Lazaret, or other Place, or other Place, where he, or the shall be so placed for Personmance of Quarentine, before he or she shall have fully personmed the same, he or she shall be adjudged guilty of Felony, and shall suffer Death as a Felon without Benefit of Clergy.

And be it further enacted by the Authority aforefaid, That if at any time or times hereafter, any City, Town, or Place within Great Britain, or Ireland, shall be infected with the Plague, shall and may be lawful to and for His Majesty, his Heirs and Successors, to cause one or more Line or Lines, Trench or Trenches, to be cast up or made about such infected City, Town, or Place, at a convenient Distance from the same, in order to cut off the Communication between such infested City, Town, or Place, and the rest of the Country; and to prohibit all Persons, Goods, and Merchandizes what soever, to enter, pass, or be carried over such Lines or Trenches, unless in such Cases, and by such proper Licence, and subject to such Regulations and Restrictions for Ferformance of Quarentine, as shall be directed or permitted by any such Order or Orders, made or to be made and notified, as aforesaid; and in case any Person or Persons, being within such Lines or Trenches, or any of them, shall, during the time of such Infection, presume or attempt to come out of the same, unless in such Gases, and by such proper Licence, and subject to such Regulations and Restrictions for Persormance of Quarentine, as shall be directed or permitted by such Order or Orders, made or to be made and notified, as aforefaid; it shall and may be lawful to and for the Watchmen, or Persons appointed to guard or secure such Lines or Trenches, any of them, by any kind of Violence that the (afe shall require, to compel all and every fuch Person and Persons to return back within such Lines or Trenches; and in case any Person shall actually come out of such Lines or Trenches, or any of them (unless in such Cases, and by such proper Licence, and subject to such Regulations and Restrictions as aforesaid) every such Person shall be adjudged guilty of Felony, and suffer Death as a Felon without Benefit of Clergy.

And be it further enacted by the Authority afore-faid. That during the present Insection, and at all Times hereaster, when any foreign Country, or any Part of Great Britain or Ireland shall be insected with the Plague, it shall and may be lawful to and for any two Justices of the Peace of any County, Riding, Division, or Liberty, next to such Place where any Ship or Vessel shall be performing Quarentine, or wherein any infected Place, or any House, Lazaret, or Place for Performance of Quarentine, shall be situate, or any Lines or Trenches shall be made, as aforesaid, and they are hereby required, from time to time, when any such Town or Place shall be infected with the Plague, or any Lines or Trenches shall be made, as aforesaid, or any Persons, Ships, Goods, or Merchandizes infected, or obliged to persorm Quarentine, shall be put in any House, Lazaret, or order the Inhabitants of such and so many Parishes, Townships, Vills, or Extraparochial Places about the same respectively, as they shall judge necessary and such Inhabitants are hereb required, in ursu-

ance of flich Orders, upon Notice thereof, to keep furficient Watches by Day and Night upon fuch Town or Place to intected, and upon fuch Lines and I renches made, as aforefaid, and upon fuch Houses, Lazarets, Ships, or other Places for Performance of Quarentine, for fuch Time, in tuch Manner, and with such Numbers of Watchmen, at every Place, 34 the faid Justices by their faid Order, shall direct and appoint; and such Watchmen are hereby required not to permit or fuffer any fuch Person, . Ships, Goods, or Merchandizes, to depart, or be conveyed out of such Town or Place infected, or such Lines or Trenches made, as aforefaid, or such House, Lazaret, or other Place for performing of Quarantine, over which they shall be appointed to watch respectively, unless in such Cases, and by fuch proper Licence, as are or shall be directed or permitted by fuch Order or Orders, made or to be made and notified, as aforefaid; and in cafe any Inhabitant of any Parish, Township, Vill, or Extraparochial Place, shall neglect or refuse to keep such Watch, or to procure some able and sufficient Person to keep such Watch in his stead, according to fuch Order or Orders as shall be made by any Two Justices of the Peace in pursuance of this Act, and shall be thereof lawfully convicted upon his or her Appearance or Default, upon the Oath or Oaths of one or more credible Witnels or Witnelses, by ore or more Justices or Justices of the Peace of the County, Division, or Liberty, where such Offence shall be committed, or the Offender shall be found (which Oath such Justice or Justices of the Peace are hereby impowered and required to administer) the Person so convicted shall forfeit any Sum not exceeding one hundred Pounds, nor less than ten Pounds, at the Discretion of such Justice or Justices; one Moiery thereof to the Informer, and the other Moiety Poor of the Parish where such Offence shall be committed, the same to be levied by Distress and Sale of the Offenders Goods, by Warrant under the Hand and Seal, or Hands and Seals of fuch Justice or Justices before whom such Offender thall be convicted, as aforefaid; and every such Offender shall also by such Justice or Justices be committed to Prison, there to remain without Bail or Mainprize during the Space of two Months, and from that time until Payment of the Sum of Money so adjudged by such Justice or Justices, as aforesaid: And in case any Person or Persons appointed or retained to serve as a Watchman or Watchmen for the Purposes aforesaid, of any of them, shall be guilty of any Breach or Nega any of them, shall be guilty of any Breach or Negalect of his or their Duty in that behalf, and shall be thereof convicted upon the Oath or Oaths of one or more credible Witness or Witnesses, by one or more Justice or Justices of the Peace of the County, Division, or Liberty, where such Offence shall be committed, or the Offender shall be found (which Oath such Justice or Justices of the Peace are hereby impowered and required to administer) the Person successful for every administer) the Person so convicted shall, for every fuch Offence, forfeit any Sum not exceeding one hundred Pounds, nor less than ten Pounds, at the Discretion of such Justice or Justices; one Moiety thereof to the Informer, and the other Moiety to the Poor of the Parish where such Offence shall be committed; the same to be levied by Distress and Sale of the Offenders Goods, by Warrant under the Hand and Seal, or Hands and Seals of such Justice or Justices before whom such Offender shall be convicted, as aforesaid; and shall also for every such Offence by such Justices be committed to Prison, there to remain without Bail or Mainprize by the space of two Months, and from that time until Payment of the Sum of Money so adjudged by such Justice or Justices, as aforefaid.

And it is hereby further Enacted, That if any Officer or Officers of His Majesty's Customs, or any other Officer or Officers, Person or Persons whatsoever, to whom it doth or shall appertain to execute any Order or Orders made or to be made concerning Quarentine, and the Prevention of Infection, and notified, as aforesaid, or to see the same put in Execution, shall be guilty of any wilful Breach or Neglect of his or their Duty in that Behalf, every such Officer and Person so offershing shall forseit his Office or Employment in the Customs, or other Office or Employment, and hall

Thall become from thenceforth uncapable to hold ; And enjoy the same, or to take a new Grant thererof, and shall also forteit the Sum of one hundred Pounds; One Moiety thereof to the King, his Heirs and Successors, and the other Moiery to him or them, who shall or will sue for the same, by Action, Bill, Plaint, or Information, in any of His Majesty's Courts of Record at Westminster, Edinburgh, or Dublin, or in the proper Courts of the Isles of Guerniey, Jersey, Alderney, Sark, or Man respectively.

And whereas Cotton, Skins, and Human Hair, and certain other Species of Goods and Merchandizes, are more especially liable to retain Infection, and may be brought from Places infected into other Countries, and from thence imported into His Majesty's Dominions in Ships not obliged to perform Quarentine; be it enacted by the Authority aforesaid, That during the present Infection, and in all future Times, when any Foreign Country or Place shall be infected with the Plague, all such Goods and Merchandizes as are or shall be particularly specified for that Purpose, in-any Order or Orders made or to be made concerning Quarentine, and the Prevention of Infection, and notified, as aforesaid, imported into any Part of His Maje-Ry's Dominions from any Foreign Country or Place in any Ship or Vessel whatsoever, shall be fubject and liable to fuch Order or Orders made or to be made concerning Quarentine, and the Pre-

vention of Infection, and notified, as aforesaid.

And be it enacted by the Authority aforesaid, That if it shall appear to his Majesty, his Heirs or Successors, that during the Time of such Infestion, as aforesaid, any Ship or Vessel shall come into any Port or Place within any of His Majesty's Dominions from any Place infected with the Plague, or being laden with any Goods or Cargo taken on board such Ship or Vessel at any Place so infected, or from on board any Ship or Vessel so infected, as aforesaid, or that there shall be any Person or Persons on board such Ship or Vessel actually infected with the Plague, or that any Goods, Wares, or Merchandizes are actually in fected with the Plague, then, and in any of the faid Cases, It shall and may be lawful for His Majesty, His Heirs and Successors, by Order in Council, to direct, authorize, and impower any Person or Persons that shall be thought proper, to burn or destroy, or cause to be burnt or destroyed, such Ship or Vessel, with the Tackle, Apparel, and Futniture thereof, and fuch Goods, Wares, and Merchandizes infected, as aforesaid, or so much thereof as shall be necessary for preventing

the spreading of the Infection. And it is hereby further enacted, That after Quarentine shall have been duly performed by any Ship or Vessel, Person or Persons, obliged to perform Quarentine, according to fuch Order or Orders made and notified, as aforesaid, and this Act, and upon Proof to be made by the Oaths of the Master, or other Person having Charge of such Ship or Vessel, and of two of the Persons belonging to fuch Ship or Vestel, or upon Proof to be made by the Oaths of two credible Witnesses before the Customer, Comptroller, or Collector of the Port where such Quarentine shall be performed, or the next Port thereunto, or before any of their Deputies, or any one Justice of the Peace living near to such Port or (where such Quarentine shall have been performed in any Inland Place) before any two Justices of the Peace living near thereunto, or where such Quarentine shall have been performed within any of the faid Isles of Guernsey, Jersey, Alderney, Sark and Man, be-fore any two Justices or Magistrates of any of the said Isles respectively (which Persons are hereby authorized and required to administer such Oath) that such Ship or Vessel, and all and every such Person and Persons respectively, have duly per-formed Quarentine, as aforesaid, and that the Ship on Vessel, and all and every such Person and Persens, are free from Infection, then, and in the said respective Cases, such Customer, Comptroller, or Collector, or any of their Deputies, together with the faid Justice of the Peace, or such two Justices of the Peace, or such Jurats or Magistrates, asuforefuld, respectively, are hereby required to give a Certificate thereof; and thereupon fuch

Ship or Vessel, and all and every such Person and Persons so having performed Quarentine, shall be liable to no further Restraint or Detention upon the same Account for which such ship or Veilel, Person or Persons shall have personmed Quarentine, as aforefaid.

And it is hereby further enacted, That the Offi? cer before whom such Oath shall be made, and by whom such Certificate shall be given, shall, for such respective Oath and Certificate, demand no more, than one Shilling for each, over and above the Stamp-Duties.

Provided nevertheless, and it is hereby enacted, That all Goods, Wares, and Merchandizes, fhall, after Quarentine performed, be opened, and aired, in fuch Place or Places, and for fuch Time, and in fuch Manner, as hath been or shall be directed by His Majesty, his Heirs or Successors, by such Order or Orders, made or to be made and notified, as aforesaid; and after such Orders shall have been duly complied with, and Proof shall be made thereof by the Oaths of two or more credible Witnesses before the Customer, Comptroller, or Collector of the Port,lying next to fuch Place or Places where fuch Goods, Wares, or Merchandizes, shall have been opened and aired, as aforesaid, or any of their Deputies, and any one Justice of the Peace living near the same, or before any two Jurats or Magistrates of the said Isles of Guernsey, Jersey, Alderney, Sark, or Man respectively (who are hereby authorized and required to administer such Oath) upon Certificate and Return of such Proof by fuch Customer, Comptroller, or Collector, or any of their Deputies, or such two Jurats or Magistrates, as aforesaid, (who are hereby respectives ly required to make such Certificate and Return to the Commissioners appointed for the Manage ment of the Customs in Great Britain, or Iteland, or to the Governour or Commander in Chief, being upon the Place, in the Isles of Guernsey, Jerfey, Alderney, Sark, or Man respectively,) such-Goods, Wares, and Merchandizes, shall be forthwith discharged from any Restraint or Detention, on the same Account, by Order of the said Commissioners, or any two of them, or of the said Governour or Commander in Chief of any of the faid Isles, as aforefaid, respectively; for every of which Oath, Certificate, and Order, no more shall be demanded or taken than the Sum of one Shil-

ling.
Provided always, and be it enacted, That if any Officer or other Person shall demand or t. ke any greater Sum than is hereby allowed and limited for any such Oath, Order, or Certificate, to be administred or made in pursuance of this Act, every Person so offending shall forseit the Sum of One hundred Pounds; one Moiety thereof to His Majesty, his Heirs and Successors, and the other Moiety to him or them, who will sue for the same by Action, Bill, Plaint, or Information, in any of His Majesty's Courts of Record at Westminster, Edinburgh, or Dublin, or in the proper Courts of Guernsey, Jersey, Alderney, Sark, or Man respectively; in which Cases Costs shall be allowed to either Parry as in other Cases.

And whereas it is notorious, that notwithstanding the many good Laws made to prevent the clandestine Importation of customable and prohibited Goods and Merchandizes, a pernicious Trade, of that kind, is still carried on, for the most part in open Boats, and Vessels of small Burthen, which privately, and in the Night, put into Creeks and secret Places on the Coast, thereby escaping the Observation of the Officers of the Customs; which Practices may prove highly de-trimental to the Sasety of these Kingdoms, during a Time of Infection: For Prevention thereof, Be it enacted by the Authority aforesaid, That during the present Insection, and in all suture Times, when any Part of Great Britain, Ireland, or the Isles of Guernsey, Jersey, Alderney, Saik, and Man, or France, Spain, Portugal, or the Low Countries, shall be insected with the Plague, it shalk and may be lawful to and for His Majesty, his Heirs and Successors, by his or their Proglamation, to prohibic and restrain all small Boats and Vessels. under the Burthen of Twenty Tuns, from failing or paffing out of any Port or Place of Greet Brifain or Ireland, or the Islands of Guernsey, Jerley.
