be adjudged guild of Felony, and fhall fuffer Death as a Felon without Benefit of Clergy, And be it further enacted, That if any Perfon

And be it further enasted, That if any Perfon not infected, nor liable to perform Quarentine, fhall prefume to enter any Ship. Houfe, Lagaret, or other Place fo appointed, as aforel id, whilk any Perfon or Ferfons fo infected, or be ing under Quärentine, fhall be therein, and fhall return, or attempt to return from thence, unlefs in fuch Cafes, and by fuch proper Licence, as fhall be directed or permitted by fuch Order or Orders, made or to be made and notified, as aforefaid, it fhall and may be lawful to and for the Watchmen, or other Ferfons appointed to guard or fecure fuch Ship, Houfe, Lasaret, or o ther Place fo appointed, as aforefaid, by any kind of Violence that the Cafe fhall require, to compel fuch Perfon, fo returning, or attempting to return, to repair into fome Ship, Houfe, Lazaret, or other Place, fo appointed, as aforefaid, there to continue and perform Quarentine 3 and in cafe fuch Perfon fhall actually efcape out of fuch Ship, Houfe, Lazaret, or other Place, where he, or the fhall be fo placed for Performance of Quarentine, before he or fhe fhall have fully performed the fame, he or the fhall be adjudged guilty of Felony, and fhall fuffer Death as a Felon without Benefit of Clergy.

And be it further enacted by the Authority aforefaid, That if at any time or times hereafter, any City, Town, or Place within Great Britain, or Ireland, shall be infected with the Plague, it fhall and may be lawful to and for His Majefty, his Heirs and Succellors, to cause one or more Line or Lines, Trench or Trenches, to be cast up or made about such infected City, Town, or Place, at a convenient Distance from the same, in order to cut off the Communication between such infected City, Town, or Place, and the reft of the Country ; and to prohibit all Perfons, Goods, and Merchandizes whatfoever, to enter, pafs, or be carried over fuch Lines or Trenches, unlefs in fuch Cafes, and by fuch proper Licence, and fubject to fuch Regulations and Reftrictions for Ferformance of Quarentine, as Ihall be directed or permitted by any fuch Order or Orders, made or to be made and notified, as aforefaid ; and in cafe any Perfon or Perlons, being within fuch Lines or Trenches, or any of them, shall, du-ring the time of fuch Infection, prefume or attempt to come out of the fame, unlels in fuch Gafes, and by fuch proper Licence, and fubject to fuch Regulations and Reftrictions for Performance of Quarentine, as shall be directed or per-mitted by such Order or Orders, made or to be made and notified, as aforefaid, it shall and may be lawful to and for the Watchmen, or Persons appointed to guard or fecure fuch Lines or Trenches, any of them, by any kind of Violence that the (ale shall require, to compel all and every fuch Person and Persons to return back within fuch Lines or Trenches; and in case any Person shall actually come out of such Lines or Trenches, or any of them (unlefs in fuch Cafes, and by fuch proper Licence, and fubject to fuch Regulations and Refirictions as aforefaid) every fuch Perfon fhall be adjudged guilty of Felony, and fuffer Death as a Felon without Benefit of Clergy.

And be it further enasted by the Authority aforefaid. That during the prefent Infection, and at all Times hereafter, when any foreign Country, or any Part of Great Britain or Ireland fhall be infected with the Plague, it fhall and may be lawful to and for any two Juffices of the Peace of any County, Riding, Divifion, or Liberty, next to furth Place where any Ship or Veffel fhall be performing Quarentine, or wherein any infected Place, or any Houfe, Lazaret, or Place for Performance of Quarentine, thall be fituate, or any Lines or Trenches fhall be made, as aforefaid, and they are hereby required, from time to time, when any fuch Town or Place thall be infected with the Plague, or any Lines or Trenches fhall be made, as aforefaid, or any Perfons, Ships, Goods, or Merchandizes infected, or obliged to perform Quarentine, fhall be put in any Houfe, Lazaret, or other Place for Performance of Quarentine, to order the Inhabitants of fuch and formany Parifhes, Townships, Vills, or Extraparochial Placestabout the fame respectively, as they shall judgenecessary; and fuch Inhabitants are hereb required, in ursu-

· ra . ance of fich Orders, upon Notice thereof, to keep fufficient Watches by Day and Night upon fuch lown or Place to infected, and upon fuch Lines and Frenches made, as aforefaid, and upon fuch Houses, Lazarets, Ships, or other Places for Performance of Quarentine, for fuch Time, in fuch Manner, 204 with fuch Numbers of Warchmen, areiery Place, as the faid Juffices by their faid Order, shall direct ard appoint ; and fuch Watchmen are hereby required not to permit or fuffer any fuch Person, , Ships, Goods, or Merchandizes, to depart, or be conveyed out of fuch Town or Place infected, or fuch Lines or Trenches made, as aforefaid, or fuch House, Lazaret, or other Place for performing of Qua-rantine, over which they shall be appointed to watch respectively, unless in fuch Cases, and by fuch proper Licence, as are or shall be directed or permitted by fuch Order or Orders, made or 19 be made and notified, as aforefaid; and in cafe any Inhabitant of any Parish, Township, Vill, or Extraparochial Place, shall neglect or refuse to keep such Watch, or to procure some able and sufficient Person to keep such Watch in his stead, according to fuch Order or Orders as shall be made by any Two Juffices of the Peace in purfuance of this Act, and shall be thereof lawfully convicted upon his or her Appearance or Default, upon the Oath or Oaths of one or more credible Witnels or Witnelies, by ore or more Justice or Justices of the Peace of the County, Division, or Liberty, where fuch Offence shall be committed, or the Offender shall be found (which Oath fuch Justice or Juffices of the Peace are hereby impowered and. required to administer) the Person to convicted Ihall forfeit any Sum not exceeding one hundred Pounds, nor lefs than ten Pounds; at the Diferetion of fuch Juffice or Juffices ; one Moiery thereof to the Informer, and the other Moiery to the Poor of the Parifh where fuch Offence fhall be committed, the fame to be levied by Diffress and Sale of the Offenders Goods, by Warrant under the Hand and Seal, or Hands and Seals of fuch Juffice or Juffices before whom fuch Offender hall be convicted, as aforefaid; and every fuch Offender fhall alfo by fuch Juffice or Juffices be committed to Prifon, there to remain without Bail or Mainprize during the Space of two Months, and from that time until Payment of the Sum of Money to adjudged by fuch Juffice or Juffices, as aforefaid: And in cafe any Perfon or Perfons appointed or retained to ferve as a Watchman or Watchmen for the Purpofes aforefaid, or any of them, fhall be guilty of any Breach or Negany of them, fhall be guilty of any Breach or Neg-left of his or their Duty in that behalf, and fhall, be thereof convicted upon the Oath or Oaths of one or more credible Witnefs or Witneffes, by one or more Juffice or Juffices of the Peece of the County, Division, or Liberty, where such Of-fence shall be committed, or the Offender shall be found (which Oath such Juffice or Juffices of the Peace are hereby impowered and required to administer) the Perfon for onvisted shall for every administer) the Person so convicted shall, for every fuch Offence, forfeit any Sum not exceeding one hundred Pounds, nor lefs than ten Pounds, at the Diferetion of fuch Justice or Justices ; one Moiety thereof to the Informer, and the other Moiety to the Poor of the Parish where such Offence shall be committed; the fame to be levied by Diffress and Sale of the Offenders Goods, by Warrant under the Hand and Seal, or Hands and Seals of fuch Juffice or Juffices before whom fuch Offender fhall be convicted, as aforefaid; and fhall allo for every fuch Offence by fuch Juffice or Juffices be committed to Prison, there to remain without Bail or Mainprize by the fpace of two Months, and from that time until Payment of the Sum of Money fo adjudged by fuch Justice or Justices, as aforefaid.

And it is hereby further Enadted, That if any Officer or Officers of His Majefty's Cuftoms, or any other Officer or Officers, Perfon or Perfons whatloever, to whom it doth or fhall appertain to execute any Order or Orders made or to be made concerning Quarentine, and the Prevention of Infection, and notified, as aforefaid, or to fee the fame put in Execution, fhall be guilty of any wilful Breach or Neglect of his or their Duty in that Behalf, every fuch Officer and Perfon fooffereding fhall forfeit his Office or Employment in the Cuftoms, or other Office or Employment, and thall
