(WAITING AND LOADING RESTRICTIONS) (AMENDMENT NO 287) ORDER 2009

1. Notice is hereby given that the Council of the London Borough of Merton under the powers conferred by sections 6 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers, has made the above-mentioned Orders. The Orders were made on 16 December 2009 and shall become operational on 21 December 2009.

2. The general effect of the Orders will be to:

- (a) designate parking places in the roads listed on the Schedule to this notice in which vehicles authorised by the Order may be left for any period during the permitted hours without charge;
- (b) introduce at any time waiting restrictions on the north-east side of Uckfield Grove from a point 10.5 metres south-east of the party wall on Nos 2 and 4 Uckfield Grove south-eastwards for a distance of 10 metres.

3. A copy of the Orders, and of the Council's statement of reasons for making the Orders and a plan which indicates each length of road to which the Orders relates can be inspected at Merton Link, Merton Civic Centre, London Road, Morden, Surrey.

4. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act, or of any Instrument made under it has not been complied with in relation to the Orders, may, within 6 weeks from the date on which the Orders were made, apply to the High Court for this purpose.
