BOTWELL LANE, CRANBORNE WAY, FORRIS AVEN HAVEN CLOSE, LANNOCK ROAD, MINTERNE WAY, PARK LANE, WIMBORNE AVENUE, HAYES. BIDEFORD ROAD, COLÚMBIA AVENUE, CORNWALL ROAD,

FIELD WAY, HARTLAND DRIVE, HILL LANE. HILL RISE, SHARPS LANE, WEST MEAD, TORRINGTON ROAD, WEST END ROAD, RUISLIP.

BURLEIGH ROAD, LONG LANE, TURNSTONE CLOSE BLOSSOM WAY, SNOWDEN AVENUE, SUTTON COURT ROAD, SWEETCROFT LANE, HILLINGDON. CHELWOOD CLOSE, CLOSEMEAD CLOSE, THE AVENUE, WEDGWOOD CLOSE, NORTHWOOD. DRAYTON GARDENS, WEST DRAYTON. LOWLANDS ROAD, THE LINK, THE CHASE, EASTCOTE.

Hillingdon Council gives notice that it intends to make these Orders which will:-

(a) impose waiting restrictions on the lengths of road as set out in the Schedule to this notice;

(b) amend the existing 8am to 6.30 pm Monday to Saturday waiting restrictions to operate between 10.30 and 11.30 and between 2.00pm and 3.00pm Monday to Friday, on Breakspear Road North, the south west side, between a point 1 metre northwest of the northwest boundary of The Swan public house for a distance of 7.9 metres northwestwards.

SCHEDULE

WAITING PROHIBITED AT ANY TIME

BIDEFORD ROAD, RUISLIP

Both sides, from the North western kerb line of West Mead to a point 10 metres north westwards.

BLOSSOM WAY, HILLINGDON, Both sides,

From a point in line with the southern kerbline of Sweetcroft Lane to a point 18 metres northeast of the south-western flank wall of No. 45 Blossom Way

BOTWELL LANE, HAYES

The east side, from the common boundary of No 216 and 208 Botwell Lane to a point 34 metres southwards.

BURLEIGH ROAD, HILLINGDON

Both sides, From the north eastern kerb line of Sutton Court Road for a distance of 14 metres.

CHELWOOD CLOSE, NORTHWOOD

Both sides, from the southern kerb line of The Avenue to a point 10 metres southwards

CLOSEMEAD CLOSE, NORTHWOOD

Both sides, from the northern kerb line of The Avenue to a point 10 metres northward.

COLUMBIA AVENUE, RUISLIP

(a) The north and west sides, from a point opposite the western flank wall of No. 22 Columbia Avenue to a point opposite the common boundary of Nos. 49 and 50 Columbia Avenue;

(b) The south and south east sides, from a point opposite the western flank wall of No. 22 Columbia Avenue to a point 10 metres northeast of the northeastern kerbline of the eastern north to south arm of Columbia Avenue(fronting Nos. 34 to 39);

(c) both sides of the eastern north to south arm of Columbia Avenue(fronting Nos. 34 to 39), between the southeastern kerbline of the northernmost north to south arm(fronting Nos. 40 to 50), and a point 10 metres southeastwards;

CORNWALL ROAD, RUISLIP:

(a) Both sides, From a point 10 metres north of the northern kerb line of Torrington Road to a point 5 metres northwards.

(b) the north west side, from a point 15 metres southwest of the western kerb line of Cornwall Road to a point 10 metres southwest of the western kerb line of Cornwall Road

CRANBORNE WAY, HAYES

Both sides, from the eastern kerbline of Wimborne Avenue to a point 10 metres south-eastwards.

DRAYTON GARDENS, WEST DRAYTON

(a) The north to south arm(fronting Nos. 17-72A Drayton Gardens), the west side, from the southern kerbline of the east to west arm of Drayton Gardens for a distance of 10 metres south.

(b) the east to west arm(fronting Nos. 20-52 Drayton Gardens), the south side, from the western kerbline of the north to south arm of Drayton Gardens for a distance of 10 metres east. FIELD WAY, RUISLIP

Both sides, from the north-western kerb line of Hill Lane to a point 10 metres north-westwards

FORRIS AVENUE, HAYES

Both sides, from the northern kerb line of Lannock Road to a point 15 metres northwards.

HARTLAND DRIVE, RUISLIP

Both sides, from the North western kerb line of West Mead to a point 10 metres North westwards.

HAVEN CLOSE, HAYES

Both sides, from the eastern kerb line of Park Lane to a point 10 metres south-eastwards.

HILL LANE, RUISLIP

(a) The southeast side, from a point 10 metres north east of the northern kerb line of Field Way to a point 10 metres south west of the southern kerb line of Field Way

(b) The southwest side, from a point 10 metres north east of the northeastern kerb line of Hill Rise to a point 10 metres south west of the south western kerb line of Hill Rise.

HILL RISE, RUISLIP

Both sides, from the south-eastern kerb line of Hill Lane to a point 10 metres south-eastwards.

LANNOCK ROAD, HAYES

(a) The north side, from the eastern kerb line of Forris Avenue to a point 18 metres eastwards.

(b) The south side, from the western kerb line of Forris Avenue to a point 20 metres eastwards.

LONG LANE, HILLINGDON

The southwest side, from a point 15 metres northeast of the northeastern kerb line of Turnstone Close to a point 10 metres south west of the southwestern kerb line of Turnstone Close. LOWLANDS ROAD, EASTCOTE

The south east side, From a point 10 metres northeast of the northeastern kerb line of The Link to a point 10 metres south west of the

south-western kerb line of The Link.

(a) Northeast , east and southeast sides, between a point 10 metres southeast of the southeastern kerbline of the southwest to northeast arm of Minterne Way and a point 15 metres northeast of the northeastern kerbline of the southern south east to northwest arm(fronting Nos. 1 to 71 Minterne Way)

(b) Southwest, west and northwest sides, between a point 10 metres southeast of the southeastern kerbline of the southwest to northeast arm of Minterne Way and a point in line with the southeastern flank wall of No. 87 Minterne Way. PARK LANE, HAYES

The east side, from a point 10 metres north of the northern kerbline of Haven Close to a point 10 metres south of the southern kerbline of Haven Close

SHARPS LANE, RUISLIP:

North to south arm, the east side, from a point in line with the common boundary with No 87 and The Orchard to a point 32 metres north west of the north western kerb line of Ickenham Road. SNOWDEN AVENUE, HILLINGDON:

Both sides from the south western kerb line of Sutton Court Road for a distance of 17 metres south westwards.

SUTTON COURT ROAD, HILLINGDON

(a) North and northeast side, From a point 10 metres north west of the northwestern kerb line of Burleigh Road to a point in line with the common boundary of Nos. 35 and No 37 Sutton Court Road.

(b) South and southwest side, from a point 12 metres north west of the northwestern kerb line of Snowden Avenue to a point in line with the common boundary of Nos. 35 and No 37 Sutton Court Road. SWEETCROFT LANE, HILLINGDON

(a) both sides,

Between a point 10 metres south-east of the southeastern kerbline of Hercies Road and a point in line with the north-western boundary of No. 84 Sweetcroft Lane.

(b) south west and south sides,
