

Between a point 10 metres south-east of the common boundary of Nos. 81 & 83 Sweetcroft Lane and a point opposite a point in line with the common boundary of Nos. 60 & 62 Sweetcroft Lane.

**THE AVENUE, NORTHWOOD**

(a) The north side, from a point 10 metres southeast of the eastern kerb line of Closemead Close to a point 10 metres northwest of the western kerb line of Closemead Close.

(b) The south side,

(i) from a point 10 metres southeast of the eastern kerb line of Wedgwood Close to a point 10 metres northwest of the western kerb line of Wedgwood Close;

(ii) from a point 10 metres southeast of the eastern kerb line of Chelwood Close to a point 10 metres northwest of the western kerb line of Chelwood Close.

**THE LINK, EASTCOTE**

Both sides, from the south-eastern kerb line of Lowlands Road to a point 10 metres south-eastwards.

**THE CHASE, EASTCOTE**

The northeast and southeast sides, from a point 10 metres southeast of the south eastern kerbline of the east to west arm of The Chase to a point 10 metres north east of the northeastern kerbline of the north to south arm of The Chase.

**TORRINGTON ROAD, RUISLIP**

The north side, from a point 15 metres northeast of the eastern kerb line of Cornwall Road to a point 10 metres northeast of the eastern kerb line of Cornwall Road.

**TURNSTONE CLOSE, HILLINGDON**

Both sides, from the south-eastern kerb line of Long Lane to a point 10 metres south-eastwards.

**WEDGWOOD CLOSE, NORTHWOOD**

Both sides, from the southern kerb line of The Avenue to a point 10 metres southwards
