2. The general effect of the Ealing (Southall Area 2) (Residents Parking Places) (Amendment No. *) Order 20** would be:

(a) to introduce parking places for the use by residents, their visitors and business users in lengths of the north side of Montague Waye east of Dagmar Road in place of the dual use free parking/permit holder parking place;

4. The general effect of the Waiting Restriction Order would be:

(a) to introduce single yellow line waiting restrictions applying 8am to 6.30pm on Mondays to Saturdays in the length of North Road specified in Schedule 1 to this notice;

(b) to introduce or change existing waiting restrictions to double yellow line waiting restrictions applying at any time in the lengths of roads specified in Schedule 2 to this notice.
