##### MOVEMENT OF THE UNITED KINGDOM GENERAL INDEX OF RETAIL PRICES

For the purposes of revaluing on repayment NS&I Index-linked Savings Certificates (Retirement Issue, 2nd, 3rd, 4th, 5th, 6th, 7th, 8th and 9th Index-linked Issues) and contributions under Save As You Earn savings contracts (Third Issue), the Index figure issued by the Office for National Statistics in the month of March 2010 for the month of February 2010, and applicable to the month of April 2010 is 219.2. This figure is based on the revised reference base of 100 adopted in January 1987. In accordance with the relevant prospectuses a notional Index figure of 864.7 has been calculated and will apply to Index-linked Savings Certificates purchased in March 1987 or earlier and SAYE contributions which were due for payment and made in February 1987 or earlier.

##### ROAD TRAFFIC REGULATION ACT 1984

##### THE A46 TRUNK ROAD (M40 JUNCTION 15, WARWICKSHIRE) (24 HOURS CLEARWAY) ORDER 2010

THE SECRETARY OF STATE FOR TRANSPORT hereby gives notice that he has made an Order under sections 1(1), 2(1) and (2), 4(1) and 122A of, and paragraph 27(1) of schedule 9 to, the Road Traffic Regulation Act 1984 on the A46 Trunk Road near Warwick in the County of Warwickshire.

The effect of the Order, which comes into force on 12 April 2010, will be to prohibit waiting at any time (other than in a layby) on the lengths of the A46 Trunk Road and connecting roads described in the schedule to this notice.

The Order will apply to the new road layout constructed as a result of the A46/M40 Junction 15 (Longbridge) Bypass improvement scheme. A COPY of the made Order, a plan illustrating the proposals and a statement explaining why the Secretary of State has made the Order may be inspected during office hours at Warwickshire County Council, Shire Hall, Warwick, CV34 4SA; Warwick Library & Information Centre, Barrack Street, Warwick, CV34 4TH or obtained by application to Karen Eustace at the Highways Agency, Broadway, Broad Street, Birmingham B15 1BL.

Any person wishing to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 9 April 2010, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

##### SCHEDULE

*In this schedule—*

Longbridge Roundabout means the roundabout junction of the A46 with the A429, the slip roads leading to and from the M40 at Junction 15, the link roads leading to and from Sherbourne Roundabout, the link road leading to the northbound carriageway of the A46, and the link road leading from the southbound carriageway of the A46.

Sherbourne Roundabout means the circulatory carriageway of the A46 at its roundabout junction with the B4463, and the link roads leading to and from Longbridge Roundabout.

1. a length of the northbound carriageway of the A46 between points 877 metres southwest and 1746 metres north of the centre point of Sherbourne Roundabout, including that roundabout;
2. a length of the southbound carriageway of the A46 trunk road between points 1746 metres north and 877 metres southwest of the centre point of Sherbourne Roundabout;
3. the link road leading from Sherbourne Roundabout to Longbridge Roundabout, including the segregated lane leading to the northbound carriageway of the M40;
4. the link road leading from Longbridge Roundabout to Sherbourne Roundabout;
5. Longbridge Roundabout;
6. the link road leading from Longbridge Roundabout to the northbound carriageway of the A46, including the segregated lane leading from the southbound exit slip road of the M40 at Junction 15;
7. the link road leading from the southbound carriageway of the A46 to Longbridge Roundabout;
8. the length of road leading to the southbound carriageway of the A429, from its junction with Longbridge Roundabout to a point 183 metres south of the centrepoint of that roundabout;
9. the length of road leading from the northbound carriageway of the A429, from a point 183 metres south of the centre point of Longbridge Roundabout to its junction with that roundabout, and
10. the length of road leading to the northbound carriageway of the A429 Stratford Road, from its junction with Longbridge Roundabout to a point 165 metres east of the centrepoint of that roundabout;
11. the length of road leading from the southbound carriageway of the A429 Stratford Road, from a point 165 metres east of the centre point of Longbridge Roundabout to its junction with that roundabout;
12. the length of road leading to the northbound carriageway of the B4463, from its junction with Sherbourne Roundabout to a point 64 metres northwest of the centrepoint of that roundabout, and
13. the length of road leading from the southbound carriageway of the B4463, from a point 64 metres northwest of the centre point of Sherbourne Roundabout to its junction with that roundabout.

##### ROAD TRAFFIC REGULATION ACT 1984

##### THE A46 TRUNK ROAD (M40 JUNCTION 15, WARWICKSHIRE) (40 MILES PER HOUR SPEED LIMIT AND DERESTRICTION) ORDER 2010

The Secretary of State for Transport hereby gives notice that has made an Order under sections 82(2), 83(1) and 84(1)(a) and (2), 122A of, and paragraph 27(1) of Schedule 9, to the Road Traffic Regulation Act 1984 on the A46 Trunk Road in the District of Warwick in the County of Warwickshire.

The effect of the Order, which comes into force on 12 April 2010, will be to—

- (a) impose a 40 miles per hour speed limit on the lengths of the A46 and connecting roads described in Schedule 1 to this notice, and
- (b) impose the national speed limit on the lengths of the A46 and connecting roads, described in Schedule 2 to this notice, which would otherwise be subject to a speed limit of 30 miles per hour as a result of the street lighting installed on them.

The Order will apply to the new road layout constructed as a result of the A46/M40 Junction 15 (Longbridge) Bypass improvement scheme. A copy of the made Order, together with plans illustrating the proposals, a copy of the order to be revoked and a Statement of the Secretary of State's reasons for making the Order, may be inspected during opening hours at Warwickshire County Council, Shire Hall, Warwick, CV34 4SA; Warwick Library & Information Centre, Barrack Street, Warwick, CV34 4TH or may be seen at or obtained by application to the Highways Agency, Network Delivery and Development Orders Team, 4 Broadway, Broad Street, Birmingham, B15 1BL.
