**RESTRICTION) (AMENDMENT NO. 2) ORDER 2010**  
**THE WALTHAM FOREST (BUS STOP CLEARWAYS)**  
**(AMENDMENT NO. 2) TRAFFIC ORDER 2010**

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Waltham Forest on 16<sup>th</sup> April 2010 made the above-mentioned Orders under sections 6, 45, 46 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders, as part of a major scheme of various improvements for the Cooper Avenue area, will be to:-

(a) Introduce waiting restrictions operating “at any time into certain sections of Amber Avenue, Banbury Road, Cogan Avenue, Cooper Avenue, Cormorant Close, Folly Lane, Grebe Close, Greenshank Close, Lawrence Avenue, McEntree Avenue, Osprey Close, Sinnott Road, Swift Close and Valognes Avenue;

(b) Introduce new, or extend the lengths of existing footway parking places in certain sections of Cogan Avenue, Cooper Avenue, Lawrence Avenue, McEntee Avenue, Sinnott Road and Valognes Avenue;

(c) relocate an existing bus stop clearway operating “at any time” and an existing bus stand operating “at any time” in Folly Lane.

3. Copies of the Orders, which will come into operation on 2<sup>nd</sup> August 2010 and other relevant documents can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 6 weeks from that date, at:- (a) The Information Desk, Town Hall, Forest Road, Walthamstow, E17; (b) The Waltham Forest Direct Shop, 265 Chingford Mount Road, Chingford, E4 8LP; and (c) Low Hall, Argall Avenue, London, E10 7AS.

4. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within six weeks of the making of the Orders, make application for the purpose to the High Court.

**STATION ROAD, E4**

**THE WALTHAM FOREST (WAITING AND LOADING**  
**RESTRICTION) (AMENDMENT NO. \*) ORDER 20\*\***

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Waltham Forest propose to make the above-mentioned Order under section 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Order would be to:-

(a) introduce waiting restrictions operating Monday to Saturday 7am to 9am within the length of an existing voucher parking place operating Monday to Saturday 9am to 5pm on the north-west side of Station Road, E4, at its junction with Willow Street, in order to allow loading activity to take place at this location at these times;

(b) introduce waiting restrictions operating “at any time” adjacent to the above voucher parking place in order to differentiate it from an adjoining parking place.

3. A copy of the Order, the Council’s statement of reasons for proposing to make the Order and of plans showing the location and effect of the Order can be inspected during normal office hours on Mondays to Fridays inclusive until the end of a period of 6 weeks from the date on which the Order is made or the Council decides not to make the Order, at (a) The Information Desk, Town Hall, Forest Road, Walthamstow, E17; (b) The Waltham Forest Direct Shop, 265 Chingford Mount Road, Chingford, E4 8LP; and (c) The Reception Desk, The London Borough of Waltham Forest, Low Hall, Argall Avenue, London, E10 7AS.

4. Any person desiring to object to the proposed Order or to make any other representation should send a statement in writing of either their objection and the grounds thereof or of their representation to Traffic Orders, Engineering Design, Low Hall, Argall Avenue, London, E10 7AS by the end of a period of 21 days from the date on which this Notice is published. All objections must specify the grounds on which they are made.
