NOTICE IS HEREBY GIVEN that the Council of the London Borough of Islington proposes to make the above mentioned Orders under Section 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985, in connection with the introduction of car club parking places.
 2. The general effect of these Orders would be to:
- (a) remove shared-use parking space and provide car club parking space for one vehicle in:
- (i) Chambers Road, the south-west side, opposite Nos. 13 and 14 Chambers Road:
- (ii) Nugent Road, the south-west side, approximately 12 metres southeast of Spears Road;
- (b) remove permit holders' parking space and provide car club parking space for one vehicle in:
- (i) Leigh Road, the north side, adjacent to No. 1 Roselwigh Avenue;
