### **ROAD TRAFFIC REGULATION ACT 1984**

**THE LEWISHAM (SPECIAL PARKING AREA) (LEWISHAM CONTROLLED PARKING ZONE) (PARKING PLACES) (AMENDMENT NO. 6) ORDER 2010**

**THE LEWISHAM (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 139) TRAFFIC ORDER 2010**

1. Notice is hereby given that Lewisham Council made these two Orders under the provisions of sections 6 and 45 as appropriate of the Road Traffic Regulation Act 1984 on 30 April 2010. Both Orders come into force on 17 May 2010.

2. The general nature and effect of the two Orders is respectively to—

- (1) Extend the Lewisham Controlled Parking Zone into Sunninghill Road and make minor amendment to the parent controlled parking zone Order in the light of the Traffic Management Act 2004; &
- (2) Introduce there supporting “No Waiting At Any Time” restriction outside the designated parking places adjacent to the rear access to Grover Court and around central island/open space (with optional no waiting Mondays to Saturdays 9.00 am to 6.30 pm restriction underlying the parking places in the event any parking space should be removed).

3. The operational hours throughout the controlled zone are Mondays to Saturdays from 9.00 am to 6.30 pm. Provisions in the Sunninghill Road extension are to be resident permit holders’ places only (except for existing red route parking bays close to junction Loampit Hill).

4. Parking charges are as existing in the Lewisham Controlled Parking Zone, including—

- (a) Resident’s permit/resident’s carer’s permit: £60 per year; resident’s permit free to resident disabled person’s badge holders;
- (b) Visitor’s permit: £1.70 for up to 5 hours on any 1 day; £2.80 per day; £8 per week.

5. Copies of documents giving more detailed particulars of the Orders and measures can be inspected during office hours on Mondays to Fridays at the office of Lewisham Highways Development, Wearside Service Centre, Wearside Road, Ladywell SE13 (tel 020 8314 2265).

6. Any person wishing to question the validity of the Order or any of its provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984 or that any requirement of that Act or of any instrument or relevant regulation made under the Act has not been complied with may, within 6 weeks from the date on which the Order was made, apply for the purpose to the High Court.

2. The general effect of

- (a) the Newham (Little Ilford) (Disabled Resident Parking Places) (Special Parking Area) (No. 1, 2005) (Amendment No.) Order 2010;
- (b) the Newham (Upton Park) (Disabled Resident Parking Places) (Special Parking Area) (No. 1, 1997) (Amendment No.) Order 2010;
- (c) the Newham (West Ham) (Disabled Resident Parking Places) (Special Parking Area) (No. 1, 2005) (Amendment No.) Order 2010;

will be to:

- (a) designate parking places for use only by persons who are resident within the Little Ilford, Upton Park and West Ham Controlled Parking Zones, who meet the current criteria for provision of parking places for disabled persons and who display Disabled Resident Parking Permits on their vehicles. Certain other vehicles may wait in the parking places in certain circumstances, e.g. to load or unload goods or pick up or set down passengers. Parking places will be designated outside each of the following locations:-

#### ***Upton Park Controlled Parking Zone***
