The Beef and Veal Labelling Regulations (Northern Ireland) 2010 No. 2010/155. - Enabling power: European Communities Act 1972, s. 2 (2). - Issued: 19.04.2010. Made: 14.04.2010. Coming into operation: 17.05.2010. Effect: S.R. 2009/2 revoked. - EC note: These regs enforce Articles 5a, 5b and 5c of Commission Regulation (EC) No. 1825/2000 (regulation 5(1) (b)) and provide rules for the provision of information for non-prepackaged meat of bovine animals aged 12 months or less at the point of sale (regulation 5(2)). They continue to enforce Title II of Regulation (EC) No. 1760/2000 establishing a system for the identification and registration of bovine animals and regarding the labelling of beef and beef products and subsidiary Commission Regulations. They also enforce the provisions relating to bovine animals aged 12 months or less contained in Council Regulation (EC) No. 1234/2007 establishing a common organisation of agricultural markets and on specific provisions for certain agricultural products as well as the provisions of Commission Regulation (EC) No. 566/2008 laying down detailed rules for the application of Council Regulation (EC) No. 1234/2007 as regards the marketing of the meat of bovine animals aged 12 months or less. - 8p.: 30 cm. - 978-0-337-98109-8 £5.75
