NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bromley on 11 June 2010 made the above-mentioned Order under Sections 6 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, and of all other powers thereunto enabling, which will come into operation on 1<sup>st</sup> July 2010.

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Enfield (the Council) on 23<sup>rd</sup> June 2010 made the Enfield (20 m.p.h. Speed Limit) (No. 3) Traffic Order 2010, the Enfield (Waiting and Loading Restriction) (Amendment No. 52) Order 2010 and the Enfield (Prohibition of Stopping Outside Schools) (Amendment No. 4) Order 2010 under sections 6, 84(1), 84(2) and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders will be to:

(a) introduce a 20 mph speed limit for motor vehicles in parts of the street specified in Schedule 1 to this Notice at such times as it is indicated by traffic signs (typically from 8.15 am until 9.15 am, 11.30 am until 1.30 pm and from 2.45 pm until 4.00 pm on Mondays to Fridays);

(b) introduce new "at any time" waiting restrictions in parts of Charlton Road N9, Cuckoo Hall Lane N9, Nightingale Road N9, Beatrice Road N9, Clifford Road N9, Devonshire Road N9, Scarborough Road N9, Shirley Grove N9, St Mary's Road N9, Wellstead Avenue N9 and the service road fronting Nos. 254 to 268 Nightingale Road N9;

(c) remove the 2 existing school keep clear markings in Nightingale Road that are no longer required.

3.
