

question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order may within 42 days of the 30th June 2010 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
