

- (xiv) Laburnum Avenue, Sutton at its junctions with Brookfield Avenue and Erskine Road;
- (xv) Longlands Avenue, Coulsdon at its junction with Hillcrest Parade and outside No. 1 and Nos. 22/25 "Hillcrest Parade";
- (xvi) Ridge Park, Purley at its junction with The Ridge;
- (xvii) The Mount, Coulsdon, at 3 locations; at its junction with Hillcrest Parade; outside No. 1 "Hillcrest Parade" and Nos. 5 and 6/8 "Hillcrest Parade";
- (xviii) The Ridge, Purley at its junction with Ridge Park and at its junctions with Woodcote Drive and Great Woodcote Drive;
- (xix) Woodcote Drive, Purley at its junction with The Ridge and Great Woodcote Drive;

(b) introduce waiting restrictions "no waiting between 8.00 a.m. and 6.30 p.m. on Mondays to Fridays inclusive" in Laburnum Avenue, Sutton at 4 locations outside No. 4, Nos. 6 and 8, 10 and 12 and 14 to 18;

(c) redefine and extend existing waiting restrictions "no waiting between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive" as "no waiting at any time" in Leicester Close, Worcester Park on the south-east side at its junction with Willowhayne Gardens;

(d) redefine existing waiting restrictions "no waiting between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive" as "no waiting at any time" in the following lengths of road in

(i) Leicester Close, Worcester Park, on the north-west side at its junction with Willowhayne Gardens;

(ii) Willowhayne Gardens, Worcester Park, at its junction with Leicester Close.

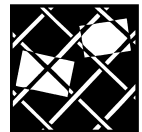
