LLOYD'S AVENUE - RELOCATION OF PARKING FACILITIES LONDON WALL/ OLD BROAD STREET - PEDAL CYCLE EXEMPTION

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London on 23 July 2010 made orders under section 6 and section 45 of the Road Traffic Regulation Act 1984.

2. The effect of the orders will be to:

(a) allow two way working for pedal cycles in Lombard Street, between King William Street and Abchurch Lane and in Lloyd's Avenue;

(b) relocate the existing parking facilities on the west side of Lloyd's Avenue, to the east side of that street; and

(c) allow pedal cycles to turn right from London Wall into Old Broad Street.

1. NOTICE IS HEREBY GIVEN that Greenwich Borough Council on 23rd July 2010 made the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Orders will come into operation on 2^{nd} August 2010.

2. The general effect of the Orders will be to:-

(1) introduce a "Pedestrian Zone" in Woolwich New Road, between its junction with Beresford Street/Plumstead Road and its junction with Thomas Street/Wilmount Street and in Vincent Road, between its junction with Woolwich New Road and a point 45 metres southeast of that junction. This will be achieved by banning all motor vehicles from entering these lengths of roads at any time, except for the following:

(a) buses and taxis;

(b) vehicles entering Woolwich New Road at its junction with Beresford Street/Plumstead Road for the purposes of loading/unloading at any time in the proposed loading place which will be situated outside Nos. 3 to 11 Woolwich New Road;

(c) permit holders' vehicles entering Woolwich New Road at its junction with Beresford Street/Plumstead Road for the purpose of gaining access to the service area at the rear of Equitable House, No. 10 Woolwich New Road (permits will be issued by Greenwich Council to the occupiers of this property only);

(d) vehicles entering the length of Woolwich New Road that lies southwest of Vincent Road by turning left from Vincent Road, between 7pm on one day and 7am on the following day on Mondays to Sundays, for the purposes of loading/unloading in the proposed loading bay which will be situated outside No. 41 Woolwich New Road;

(2) close General Gordon Place to all vehicles by erecting barriers at each end:

(3) ban motor vehicles from entering Green's End at its junction with Thomas Street:

(4) compel the left turn by vehicles from Vincent Road into Woolwich New Road (except for buses, taxis and pedal cycles);

(5) compel the left turn by vehicles from Love Lane into Thomas Street:

(6) revoke the one-way working in Vincent Road and any existing restrictions on vehicle movements that conflict with the new restrictions described in paragraphs (1) to (5) above and to revoke and re-enact certain existing Orders so as to consolidate several existing restrictions on vehicle movements into one Order;

(7) ban waiting by vehicles at any time in the lengths of roads specified in Schedule 1 to this Notice and ban waiting by vehicles, including waiting for the purpose of loading or unloading, at any time in the lengths of roads specified in Schedule 2 to this Notice (instead of the existing waiting and loading restrictions that currently apply in these lengths of roads);

(8) provide new loading places (a) on the east side of Parry Street, just North of No. 1 Parry Street, (b) on the south-east side of Woolwich New Road outside Nos. 3 to 11 Woolwich New Road, (c) on the south-west side of Spray Street opposite No. 13 Woolwich New Road,
