The Council of the London Borough of Barking and Dagenham in exercise of its powers under Sections 6, 32, 121A, 124 and Parts I to IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling and amending legislation and powers and after consultation with the Commissioner of Police of the Metropolis in accordance with Part III of Schedule 9 of the Act on 30 August 2010 made the above named Orders the effect of which:

1. Amends the London Borough of Barking and Dagenham (Heathway) (Parking Places) Order 1996 by removing all permit parking places on the south side of Moss Road between its junctions with Rectory Road and Ford Road.
2. Amends the London Borough of Barking and Dagenham (Special Parking Areas) (No.1) Order 1994 so as to:

- Prohibit waiting at all times on the south side of Moss Road between its junctions with Rectory Road and Ford Road.
- Prohibit waiting at all times on the east side of Ford Road and west side of Rectory Road at their junctions with Moss Road.
- Address anomalies in the wording of Schedule 1 insofar as it relates to Ford Road for ease of future reference.

Copies of the Orders together with a statement of the Council's reasons for proposing these Orders are available for inspection at the Planning Application Desk, Maritime House, Linton Road, Barking and at the offices of the Chief Executive, Civic Centre, Dagenham between the hours of 9.00am and 4.00pm.

Any person wishing to question the validity of the Order or of any of its provisions on the grounds that they are not within the powers of the Act, or that any requirements of the Act or any Regulations under it have not been complied with may do so within six weeks of the date of the Order by applying to the High Court.

The section of footpath to be stopped up is situated in front of 3 Brandon Close and runs along the rear of Barford Close and Wisbech Close to the side of 2 Watton Close. The length of the footway is approximately 60 metres in length and having a width between 1.8 and 2.0 metres.

**PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS)

**DESIGNATION OF THE PANT GLAS AND BROGYNTYN PARK
CONSERVATION AREA**

NOTICE IS GIVEN under the provisions of the 1990 Act that Shropshire Council, after consulting with local residents and English Heritage, has determined that the area described in the Schedule to this Notice is an area of special architectural or historic interest, and that it is desirable to preserve or enhance its character and appearance. It has accordingly designated The Pant Glas and Brogyntyn Park Conservation Area.

The principal effects of land being included within the Conservation Area are as follows:

1. The Council is required to formulate and publish proposals for the preservation and enhancement of the Conservation Area.
2. Consent must be obtained from the Council for the demolition of any building in the area.
3. Six weeks notice must be given to the Council before works are carried out to any tree in the area.
4. Special publicity must be given to planning applications for development in the Conservation Area.
5. In carrying out any functions under the Planning Acts (and, in particular, in determining for planning permission and listed building consent), the Council and the Secretary of State are required to take into account the desirability of preserving or enhancing the character or appearance of the area.
