#### DESIGNATION OF EXTENSIONS TO SOPWELL AND ALTERATIONS AND EXTENSIONS TO LONDON COLNEY CONSERVATION AREAS.

Notice is hereby given, pursuant to Section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990, that the Council has designated extensions to Sopwell Conservation Area and alterations and an extension to London Colney Conservation Area.

Sopwell Conservation Area

The extension includes the following:- Land adjacent to the south of the Sopwell House Hotel and east of New Barnes Mill, Cottonmill Lane, Sopwell, St Albans.

The boundary of the conservation area has been extended from the west boundary of Sopwell House southeastwards along the field boundary as far as the woodland on the edge of Verulam Golf Course and returns northwestwards to join the present boundary.

The second extension includes the whole of the car park and adjacent tree belt to the east of New Barnes Mill. The extended boundary runs from the present northeast corner adjacent to the River Ver and follows the east side of the tree belt adjacent to the car park as far south as the present boundary on Cottonmill Lane.

London Colney Conservation Area

The extension includes the section of car park and landscaped grounds to the east of the existing boundary at the property named Colney Fox Public House, Barnet Road, London Colney. The amended boundary commences at the existing easternmost point to the rear of 37 Lowbell Lane and continues south following the party boundary edges of the three garage courts belonging to the flats to the east. The southern end continues the party boundary to Watersplash Court as far south as Barnet Road where it rejoins the existing boundary

The boundary has also been amended to exclude five properties in Willowside, Nos. 10, 10a, 11, 12 and 13. The new boundary follows the party boundary of Waterside House northwards from Willowside and continues eastwards along the rear boundaries of properties in Waterside and Barnet Road, taking in the small plot to the rear of Bull Cottage and The Bull P.H., as far as the existing Conservation Area boundary to the rear of Midhurst, Barnet Road.

Maps showing the areas may be inspected during normal office hours at the Council Offices, Civic Centre, St Peter's Street, St Albans.

The effect of the designations is described in the Act, but the Council has a duty to pay special attention to the desirability of preserving or enhancing the character or appearance of the areas.

In particular no building may be demolished without the consent of the Local Authority, and no trees over 75mm in diameter may be cut down, uprooted, topped or lopped without consent.
