THE HARROW (PRESCRIBED ROUTE) (NO. 2) TRAFFIC ORDER 2010

- 1. NOTICE IS HEREBY GIVEN that the London Borough of Harrow has made the above mentioned orders under Sections 6, 7, 84, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and all other enabling powers.
- 2. The Harrow (Speed Limit) (Amendment No.9) Traffic Order 2010 amends the existing extents of the 40mph speed limit in Honeypot Lane, by extending the existing 30mph speed limit as follows. Vehicles proceeding in the southbound carriageway of Honeypot Lane are prohibited from entering or turning right into the gap in the central reservation in Honeypot Lane located opposite Nos. 410 and 412 Honeypot Lane. A banned left turn has been introduced at the junction with Collins Avenue to supplement the existing no entry.
- 4. A copy of the orders, which will come into operation on 22nd November 2010, including documents giving more particulars of the orders, are available for inspection at request between 9am and 5pm, Mondays to Fridays at the One Stop Shop at the Civic Centre, until 6 weeks from the date on which the order was made.
- 5.
