Notice is hereby given that Sevenoaks District Council has reviewed the existing Conservation Area at Riverhead and resolved on 10th June 2010 that the boundary should be varied under section 69 of the above Act.

Since the area was first designated in 1974, it has been extended in 1992 and in 2010, covering the centre of the village around the junction of The Square and Amherst Hill. The area also extends southwards and northwards along London Road, and includes part of Chipstead Lane and Worship's Hill.

It is proposed to extend the area to include 15 properties in Montreal Drive and several additional properties in Worship's Hill.
