1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent propose to make the above mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Traffic Management Act 2004.

2. The general effect of the "Disabled Persons Parking Places" Order would be to:-

(a) designate parking places in certain lengths of the streets specified in the Schedule to this Notice in which vehicles authorised by the Order may be left for any period without charge;

(b) provide that the parking places would operate "at any time";

(c) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 may be left therein;

(d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc;

(e) revoke the existing disabled parking place outside No. 14 Ambleside Road, NW10 3UJ.

3. The general effect of the 'Parking Places Amendment' Orders would be to:-

(a) reduce in length and redefine existing permit parking places in association with the provision of disabled persons parking places in Grove Road and Thurlow Gardens;

(b) reduce in length and redefine existing Wembley Stadium Event Day parking places in association with the provision of disabled persons parking place in Farm Avenue.

4.
