### Road Traffic Acts

#### London Borough of Hounslow

PROPOSED WAITING RESTRICTIONS IN VARIOUS ROADS IN BEDFONT, BRENTFORD, FELTHAM, HESTON, HOUNSLOW AND ISLEWORTH.

##### A. THE LONDON BOROUGH OF HOUNSLOW (WAITING AND LOADING RESTRICTION) (AMENDMENT NO.33) ORDER 2010

1. The Council of the London Borough of Hounslow has made the above mentioned Order on 13 December 2010 under sections 6 and 124 of the Road Traffic Regulation Act 1984 as amended. The Order will come into operation on 29 December 2010.
2. The general effect of the Waiting and Loading amendment Order will be to further amend the London Borough of Hounslow (Waiting and Loading Restriction) Order 2008 so that waiting by vehicles would be prohibited in certain lengths of road as specified in Schedules 1, 2 and 3 to this Notice. Full details of the new waiting restrictions can be inspected as detailed in Article 4 below.
3. The Council has made the decision to defer implementing the remaining waiting restrictions in those lengths of roads that were originally published in Notice of Proposal on the 1 October 2010 and 12 November 2010 which are not included in this Order. The roads which are to be deferred to a later date are specified in Schedule 4 to this Notice. The Council shall seek to bring into force subsequent Orders for those lengths of roads which have been deferred within a period of 2-years of when the original Notice of Proposal was published.
4. A copy of; the Order; the above-mentioned Order of 2008; the Council's statement of reasons for making the Order; plans which show the lengths of road to which the Order relates, can be inspected until the end of 6 weeks from the date on which this Notice is published, on-line at [www.hounslow.gov.uk](http://www.hounslow.gov.uk), or at Forms and Document Counter, Civic Centre, Lampton Road, Hounslow TW3 4DN between 9am and 4.15pm Monday to Friday. Further information may also be obtained by telephoning the Environment Department on 020 8583 3322.
5. Any person desiring to question the validity of the Order or any provision contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act, as amended, or that any of the relevant regulations made thereunder have not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make an application for the purpose to the High Court.

#### CONTROLLED PARKING ZONE AMENDMENTS

##### PARKING PERMIT CHARGES AND CONDITIONS

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames propose to make the following Order under sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended:

- The Kingston upon Thames (Parking Places) (Amendment No. \*) Order 20\*\*.

2. The general effects of the Order, in line with the Council's Notices of Variation (to increase off-street and on-street parking charges), would be to amend certain provisions of the Orders listed in the Schedule to this Notice as follows;

- (a) to introduce new criteria when applying for Business Parking Permits by allowing the following quantities:- 1 permit, '2 to 5' permits and '6 or more' permits (the current limit is 2 permits per business user);
- (b) to assign charges for the proposed quantities of Business Parking Permits as follows;

Quantity and Duration	Charge
1 permit – 1 year	£300
1 permit – 6 months	£180
1 permit – 3 months	£100
'2 to 5' permits – 1 year	£450
'2 to 5' permits – 6 months	£270
'2 to 5' permits – 3 months	£150
'6 or more' permits – 1 year	£675
'6 or more' permits – 6 months	£405
'6 or more' permits – 3 months	£225

(c) to amend the conditions for the refund of unexpired Parking Permits so that a refund for a Business or Residents' Parking Permit be given for blocks of 3 complete months before the expiry date (currently, a refund is given for each complete month).

Please note:- Business Parking Permits will continue to be unavailable in Kingston Town (Zone A/A1).
