

(b) loading and unloading by vehicles would be prohibited in the lengths of roads as specified in Schedules 3, 4, 5 and 6 to this Notice.

3. The general effect of the Parking Places Amendment Order will be to further amend The London Borough of Hounslow (Chiswick Inner Core) (Parking Places) (No.17) Order 2009 so that the designation of the parking places on Heathfield Terrace are amended as specified in column 2 of Schedule 7 to this Notice.

4. A copy of; the Orders as made; the above-mentioned Orders of 2008 and 2009; the Council's statement of reasons for making the Orders; a plan which shows the lengths of road to which the Orders relate, can be inspected until the end of six weeks from the date on which this Notice is published at the following locations and during the opening hours shown.
