**(proposed amendment to the description of residents' parking bays)**

**Linden Gardens, Chiswick** – resident bays in the north-eastern and south-western arm of Linden Gardens in which cars parked at an angle to the kerb-line will remain as is, but will be remarked on street and the description will be amended in the TMO

**Chiswick Common Road, Chiswick** – south-east side, 6.0 metres west of the western kerb-line of Elliott Road to a point 16.5 metres west of the boundary wall of Nos. 3/4 Victor Villas, Chiswick Common Road.

**London Borough of Hounslow****REVISED SPEED LIMITS - BEDFONT RD (STANWELL) AND STANWELL RD**

**THE LONDON BOROUGH OF HOUNSLOW (SPEED LIMITS) (NO.1) ORDER 2011**

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Hounslow on 17 January 2011 made the above Order under sections 84 of the Road Traffic Regulation Act 1984.

2. The general effect of the Speed Limit Order will be to impose a speed limit of:

(a) 50mph in the length of Stanwell Road from its junction with the A30 Great South West Road to a point 62m south-east of the north-western point of the central reservation of Stanwell Road to the south-east of Beacon Road Roundabout.

(b) 40mph in the length of Stanwell Road, Feltham from its junction with Bedfont Road (Stanwell), Feltham to a point 62m south-east of the north-western point of the central reservation of Stanwell Road to the south-east of Beacon Road Roundabout.

(c) 40mph in the length of Bedfont Road (Stanwell), Feltham from its junction with Stanwell Road to the boundary of the Administrative County of Surrey.
