# THE BEXLEY (LOADING PLACES) ( AMENDMENT NO.5) TRAFFIC ORDER 2011

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley on 24th January 2011 made the above mentioned Orders under sections 6, 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, and Part 6 and Schedules 7 to 12 of the Traffic Management Act 2004, and all other enabling powers

2. The general effect of the Bexley (Waiting and Loading Restriction) (Amendment No.16) Traffic Order 2011 would be to further amend the Bexley (Waiting and Loading Restriction) Order 2009 to:-

Revise waiting and loading restrictions on Welling High Street (in the vicinity of the Embassy Court development) introducing no waiting and no loading at any time restrictions

3. The general effect of the Bexley (Welling Town Centre) (Parking Places ) (Amendment No.7) Traffic Order 2011 would be to:-

Relocate some pay and display bays on the north side of Welling High Street, extend an existing pay and display parking place on the south side, and relocate parking meter bays on the south side to the east of their current location.

4. The general effect of the Bexley (Loading Places) (Amendment No. 5) Traffic Order 2011 would be to:-

Revoke the existing loading place in front of numbers 54 and 56 Welling High Street and introduce a new loading place for goods vehicles east of the current position.

## PROPOSED 7.5 TONNE LORRY BAN IN SANDOWN ROAD, COULSDON

1. NOTICE IS HEREBY GIVEN that Croydon Council propose to make an Order under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

2. The general effect of the Order would be to prohibit goods vehicles exceeding 7.5 tonnes maximum gross weight from entering Sandown Road, Coulsdon, except when requiring access to properties in that road.

# PROPOSED PART-TIME PEDESTRIAN ZONE IN SURREY STREET, CROYDON.

1. NOTICE IS HEREBY GIVEN that Croydon Council, proposes to make a Traffic Order under Section 6 of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers.
