## Department for Transport ROAD TRAFFIC REGULATION ACT 1984

THE A259 TRUNK ROAD (LITTLE COMMON ROAD, BEXHILL) (30 MILES PER HOUR SPEED LIMIT) ORDER 201

THE SECRETARY OF STATE FOR TRANSPORT gives notice that he proposes to make an Order under sections 82(2), 83(1), 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984 on the A259 Trunk Road at Bexhill

in the County of East Sussex.

THE EFFECT of the Order would be to impose a 30mph speed limit on both carriageways of the A259 Little Common Road at Bexhill from its junction with Sutherland Avenue (B2098) to a point 90 metres west of Knebworth Road, a distance of approximately 335 metres. The existing 40mph speed limit Order would be varied to exclude this length of road.

A COPY of the draft Order, of a plan illustrating the proposal, of the Order to be varied and of a statement explaining why the Secretary of State proposes to make the Order may be inspected during office hours at the offices of Rother District Council, Town Hall, Bexhill-on-Sea, East Sussex, TN39 3JX and during opening hours at Bexhill Library, Western Road, Bexhill-on-Sea, East Sussex, TN40 1DY, until the end of the objection period below.
