

## London Borough of Lambeth

### PROPOSAL TO PROVIDE NEW DISABLED PERSONS' PARKING PLACES AND TO FORMALLY DESIGNATE, MAKE CHANGES TO AND REVOKE CERTAIN EXISTING DISABLED PERSONS' PARKING PLACES

(Note: This notice is about the Council's proposal to provide new disabled persons' parking places in the roads specified in this notice, extend the length of an existing bay in Lilford Road and an existing bay in Loughborough Park and to formally designate and revoke certain other disabled persons' parking places that are no longer required in the borough. Objections may be made – see paragraph 6)

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth propose to make the Lambeth (Free Parking Places) (Disabled Persons) (No. \*\*) Order 2011 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

2. In brief, the general effect of the Order would be:-

(a) to designate disabled persons' parking places on the streets specified in Schedule 1 to this Notice;

(b) to extend the length of existing disabled persons' parking places in (i) Lilford Road (outside No. 54); and (ii) Loughborough Park (outside No. 59);

(c) to revoke disabled persons' parking places on the streets specified in Schedule 2 to this Notice.

3. The parking places referred to in paragraph 2(a) above would operate at any time and would be available for use only by vehicles which display in the relevant position a valid disabled persons' blue badge issued by a local authority.
