OTICE IS HEREBY GIVEN that Croydon Council on the 7 February 2011 made the above mentioned Order under the relevant Sections of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers.

#### **DISABLED PERSONS PARKING PLACES - VARIOUS** LOCATIONS

1. NOTICE IS HEREBY GIVEN that Croydon Council propose to make Traffic Orders under the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

2. The general effect of the Orders would be to designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge:
