- (b) the Enfield (Free Parking Places) (Disabled Persons) (No.*) Order 201*:
- (c) the Enfield (Parking Places) (Pay and Display) (Upper Edmonton)(No. *) Order 201*; and
- (d) the Enfield (Waiting and Loading Restriction) (Amendment No.) Order 201*—

under sections 6, 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended.

- 2. The general effect of the Orders would be to:
- (a) introduce a controlled parking zone into an area surrounding North Middlesex Hospital, by providing residents' parking places;
- (b) provide formal disabled persons parking places and 'Pay and Display' parking places;
- (c) introduce new waiting restrictions and either keep or vary certain existing waiting restrictions in the zone.
- 3. The effect of the Residents' and Shared-Use Parking Places Order would be to:
- (a) designate residents' parking places in the streets specified in Schedule 1 to this Notice and shared-use (residents' and pay and display) parking places in the street specified in Schedule 2 to this Notice at which charges may be made by the Borough Council for vehicles authorised by the Orders to be left in those parking places;
- (b) provide that the parking places would operate between 9 am and 8.30 pm on Mondays to Sundays inclusive (Christmas Day excepted); (c) specify that the vehicles which may be left in the residents' parking places shall be those displaying either a valid residents' permit, community health staff permit, social services staff permit, special permit, carers' permit or visitors parking card issued by the Council or its authorised agent under the provisions of the relevant Order;
- (d) specify that the vehicles which may be left in the shared-use parking places shall be those displaying either a valid permit referred to in paragraph 3 (c) above or a valid pay and display parking ticket issued by a parking pay and display machine provided in respect of that parking place under the provisions of this Order;
- (e) provide that the charge for the issue of a residents' permit would be £70 and which would be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (f) provide that the charge for the issue of a community health staff permit or a social services staff permit would be £15 and which would be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (g) provide that the charge for the issue of a carers' permit would be £70 and which would be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (h) provide that the charge for the issue of a special permit would be £95 and which would be valid for a period of 12 months running from the beginning of the month in which it first becomes valid;
- (i) provide that the charge for the issue of a residents' visitors parking card which, upon validation, would be valid for a single morning or afternoon period, would be £1 each. Visitor parking cards would not be valid for use on match days. Parking cards are available in booklets

- comprising 10 parking cards each (a maximum of 50 parking cards may be issued to a householder in a 12 month period);
- (j) provide that the charge for the issue of parking tickets (pay and display) would be either:
- (i) 20 pence for up to 15 minutes;
- (ii) 50 pence for up to 30 minutes;
- (iii) £1.00 for up to 1 hour; or
- (iv) £2.00 for up to 2 hours;
- (k) provide that certain vehicles may wait free of charge in certain circumstances, e.g. to allow persons to board or alight (maximum two minutes), to load or unload (maximum 20 minutes) and vehicles left by specified disabled persons (no time limit).
- 4. The effect of the Disabled Persons Parking Places Order would be to:
- (a) designate disabled persons parking places in the street specified in Schedule 3 to this Order in which vehicles authorised by the Order may be left for any period at any time without charge;
- (b) specify, in respect of the disabled persons parking places, that disabled persons' vehicles displaying in the relevant position a disabled person's badge issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 2000 may be left therein; and
- (c) provide that certain other vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.
