1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing, propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Parking Place Orders would be to

- convert the motorcycle parking place in Locarno Road to shop and stop parking which would operate between 8 am and 6.30pm on Mondays to Saturdays with parking limited to a period of 60 minutes. No return would be permitted to the parking place for 1 hour;
- formalise permit parking places in Locarno Road west to east arm which would operate between 9.30 am and 5.30pm on Mondays to Fridays and which would be restricted to K zone permit holders;
- remove the yellow line waiting restriction in Berrymede Road outside Nos. 19 and 23 and replace it with permit holder parking;
- remove a length of permit holder parking place opposite No.57 and 59 Cloister Road;
- revise a loading parking place in Southfield Road outside Nos. 64 and 66 so that it applies between 9am and 6pm on Mondays to Fridays and has a loading limit of 20 minutes.

3. The general effect of the Waiting Restriction Order would be to impose additional lengths of double yellow line waiting restrictions applying at any time in the lengths of roads specified in Schedule 1 to this Notice and to formalise the 9.30 am and 5.30pm on Mondays to Fridays waiting restrictions in the west to east arm of Locarno Road.

4. The Orders, precise details concerning the lengths of roads affected and other documents giving more detailed particulars of the Orders are available for inspection between 9 a.m. and 5 p.m. Mondays to Fridays inclusive at Mouchel, 6th Floor, 58 Uxbridge Road, Ealing, London W5 2ST, until 6 weeks have elapsed from the date on which either the Orders are made or the Council decides not to make the Orders.

SCHEDULE 1

Waiting restrictions to apply at any time

Aspen Lane (carriageway only)

(a) both sides, between its junction with Broadmead Road and a point 17.2 metres east of the eastern side of the footpath crossing Aspen Lane ;

(b) the north side, between a point opposite the eastern boundary of No. 11 Aspen Lane and a point 5 metres east of the eastern kerb-line of Hazeltree Lane;

(c) the south side,

(i) between a point 6.8 metres east of a point opposite the eastern boundary of No. 11 Aspen Lane and a point opposite the western wall of No. 92 Aspen Lane;

(ii) between a point opposite the south-eastern boundary of No. 85 Aspen Lane and a point 5.3 metres north-west of a point in line with the north-western wall of No. 79 Aspen Lane.

Broadmead Road (carriageway only)

the north-west side, between a point 10.9 metres north-east of a point in line with the north-eastern wall of No. 92 Aspen Lane and a point 7.2 metres south-west of a point in line with the southern boundary of No. 1 Aspen Lane.

Dilston Close

(a) the north-east side, between its junction with the service road on the south-east side of Yeading Lane and a point opposite the north-western wall of No. 1 Dilston Close;

(b) the south-west side, between its junction with the service road on the south-east side of Yeading Lane and a point opposite the north-western wall of No. 2 Dilston Close

Faraday Road, Southall

the south side, between a point 5.7 metres west of a point opposite the eastern wall of Dormers Wells Lodge and a point 13.7 metres west of that wall.

Hazeltree Lane (carriageway only)

(a) the east side, between its junction with Aspen Lane and a point 6.4 metres south of the common boundary of Nos. 9 and 10 Aspen Lane;

(b) the west and south sides, between its junction with Aspen Lane and a point opposite the western wall of No. 56 Hazeltree Lane.

Kingston Close

(a) the north-east side, between a point 3.7 metres south-east of the common boundary of Nos. 86 and 88 Kingston Close and its south-eastern extremity;

(b) the south-west side, between a point opposite the north-western wall of Nos. 46, 48 and 50 Kingston Close and its south-eastern extremity;

(c) the south-east side

(i) between the north-eastern kerb-line and a point 5.0 metres south-west of that kerb-line;

(ii) between the south-western kerb-line and a point 5.0 metres north-east of that kerb-line.

Locarno Road, W3

the north to south arm, the north side, between the eastern kerb-line and the western kerb-line;

Sandringham Road

the east side, between a point 10 metres south of the southern kerb-line of Belvue Road and a point opposite the northern most wall of No.1 Sandringham Road.

Southfield Road

The north side, between a point 3 metres west of a point opposite the eastern boundary of No. 60 Southfield Road and a point 13.70 metres south-east of a point opposite the party wall of Nos. 66 and 68 Southfield Road;

Telford Road, Southall

the south-east side, between a point 1 metre north-east of a point opposite the south-western side of the accessway leading to garages that lies north-east of No. 1 Telford Road and a point 2.5 metres south-west of a point opposite the south-westernmost wall of Dormers Wells Lodge.
