NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet propose to make the above mentioned Orders under sections 6, 45, 46, 49 and 51 to the Road Traffic Regulation Act 1984 and all other enabling powers.

The general effect of the Orders would be to provide or remove redundant disabled parking bays for vehicles displaying a valid disabled Blue Badge at the following locations:

#### New disabled parking bays operational, at any time, for vehicles displaying a valid Blue Badge:

119 Arlington Road N14, 54 Balfour Grove N20, 16 Benningholme Road Edgware, 11 Bramber Road N12, 28 Brookfield Crescent NW7, 29 Dallas Road NW4, 6 Fallow Court Avenue N12, 8 Grants Close NW7, 32 Holyrood Road New Barnet, 56 Llanvanor Road NW2, 16 Lynton Avenue NW9, 1 Maytree Close Edgware, 35 Vernon Crescent East Barnet, 45 Vernon Crescent East Barnet and 183 Watling Avenue Burnt Oak.

The bays at 29 Dallas Road NW4 and 56 Llanvanor Road NW2 would be provided by converting existing resident permit parking places.

The disabled parking bay outside No. 30 Fallow Court Avenue N12 will be relocated to allow a more appropriate parking layout.

#### Redundant disabled parking bays:

It is also proposed to remove the following redundant disabled parking bays and where noted convert to permit parking places:

15 Brunswick Crescent N11, 50 Cloister Road NW2, 2a Elmcroft Avenue NW11 (convert to permit parking space), 23 Fuller Street NW4, 20 Hampstead Gardens NW11 (convert to resident permit parking space), 29 Johns Avenue NW4 (convert to resident permit parking space), 72 Woodfall Avenue Barnet and 79 Worcester Crescent NW7.
