NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent on 14 March 2011 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Traffic Management Act 2004. 2. The general effect of the 'Disabled Persons Parking Places' Order will be to:—
- (a) designate parking places in certain lengths of the streets specified in the Schedule to this Notice in which vehicles authorised by the Order may be left for any period without charge;

(b) provide that the parking places would operate "at any time";

- (c) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 may be left therein;
- (d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc; (e) revoke existing disabled parking places outside No. 36 Douglas Road, NW6, No. 43 Huddlestone Road, NW2, No. 20 Keslake Road, NW6, No. 102 Olive Road, NW2, No. 53 Victor Road, NW10 and No. 85 Woodstock Road HA0;
- (f) relocate an existing disabled parking place outside No. 52 Norton Road, HA0.
- 3. The general effect of the 'Free Permit Parking Places' Order will be to revoke the existing personalised disabled persons parking place outside No. 13 Fernbank Avenue, HA0 provided by the Brent (Free Permit Parking Places) (Disabled Persons) (No. 1) Order 2010.
- 4. The general effect of the 'Parking Places Amendment' Orders will be to:—
- (a) reduce in length and redefine existing resident parking places in association with the provision of disabled persons parking places in Purves Road and Torbay Road;
- (b) increase in length the existing dual use and resident parking places following the revocation of the no longer required disabled persons parking bay in Douglas Road, Fernbank Avenue, Huddlestone Road, Keslake Road, Olive Road and Victor Road;
- (c) relocate in length and redefine existing Wembley Stadium Event Day parking places in association with the relocation of the existing disabled persons parking places in Norton Road and Milford Gardens.
- 5. A copy of each of the Orders, which will come into operation on 28 March 2011, of maps of the relevant areas and of the above-mentioned Orders of 1994, 2001, 2003, 2004, 2008, 2010 (and of the Orders which have amended those Orders), 2000, 2006, 2008, 2009 and 2010, can be inspected during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made at:—
