1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council on the 7th April 2011 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.

2. The general effect of the Orders, which are proposed to allow pedal cycles to enter or leave Priory Road at its junction with Wadhurst Road, will be to

(a) prohibit vehicles (other than pedal cycles) from using the gap created in the footway at the junction of Priory Road and Wadhurst Road to permit the above-mentioned movement;

(b) remove a section of permit holder parking place on the north side of Wadhurst Road to allow pedal cycles to proceed through the gap;

(c) impose "at any time" waiting restrictions in Priory Road and the north side of Wadhurst Road adjacent to the gap.

3. The Orders, which will come into force on 11th April 2011, and other documents giving more detailed particulars are available for inspection at Customer Services Reception, Perceval House, 14-16 Uxbridge Road W5 2HL between 9:00am and 4:45pm on Monday to Friday, until the 19th May 2011.

4. Any person desiring to question the validity of any of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any relevant requirements thereof or any relevant regulations made thereunder has not been complied with in relation to any of the Orders may make application for the purpose to the High Court by the 19th May 2011.

**NOTICE OF THE ISSUE OF A SUBMARINE PIPELINE WORKS  
AUTHORISATION**

The Secretary of State for Energy and Climate Change hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by RWE Dea UK SNS Limited whose address is 4th Floor, 90 High Holburn, London, WC1V 6LJ for the construction of a pipeline system between Breagh A Platform and the Low Water Mark at Coatham Sands.

Except with the consent of the Secretary of State, the 508 Millimetre Export pipeline shall be used to convey Gas condensate, MEG and corrosion inhibitor; the 120 Millimetre supply pipeline shall only be used to convey MEG and the Fibre Optic Cable shall only be used to convey control signals.

The pipelines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

RWE Dea UK SNS Limited have been appointed operators of the pipelines.

**THE DRYSIDES INTERNAL DRAINAGE DISTRICT AND  
WHITTLESEY INTERNAL DRAINAGE DISTRICT  
(AMALGAMATION) ORDER 2010**

Notice is hereby given that the Secretary of State for the Department for Environment, Food and Rural Affairs in exercise of the powers conferred upon her by paragraph 5(1) of Schedule 3 to the Land Drainage Act 1991 has now confirmed The Drysides Internal Drainage District and Whittlesey Internal Drainage District (Amalgamation) Order 2010 (S.I. 2011 No. 814) made on 16 November 2010 confirming the Scheme submitted by the Environment Agency for confirmation under section 3(1) of that Act.

The scheme makes provision for:

- (i) the abolition of the Drysides Internal Drainage Board and the Whittlesey Internal Drainage Board;
- (ii) the amalgamation of the internal drainage districts under the jurisdiction of those internal drainage boards into one new internal drainage district;
- (iii) the constitution of a new internal drainage board for the internal drainage district formed by the amalgamation;
- (iv) matters supplemental thereto or consequential thereon.
