#### THE SCOTTISH PARLIAMENT (LETTERS PATENT AND PROCLAMATIONS) ORDER 1999

The following Letters Patent were signed by Her Majesty The Queen on the 23 April 2011 in respect of the **Double Jeopardy (Scotland) Bill asp 16**.

ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen Head of the Commonwealth Defender of the Faith To Our trusty and well beloved the members of the Scottish Parliament

GREETING:

FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of the Scottish Parliament nor have effect in the Law without Our Royal Assent signified by Letters Patent under Our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our own hand and recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill COMMANDING ALSO the Keeper of Our Scottish Seal to seal these Our Letters with that Seal.

IN WITNESS WHEREOF we have caused these Our Letters to be made Patent.

## Road Traffic Acts

DOCK ROAD, NORTH WOOLWICH ROAD, BELL LANE, SCARAB CLOSE, SEAGULL LANE, THE LOWER LEA CROSSING AND TIDAL BASIN ROUNDABOUT, THE SERVICE ROAD LEADING TO NO. 14 DOCK ROAD, TIDAL BASIN ROAD AND WESTERN GATEWAY

THE NEWHAM (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. 135) ORDER 2011

THE NEWHAM (FREE PARKING PLACES) (DISABLED PERSONS) (NO. 1, 1989) (AMENDMENT NO. 51) ORDER 2011

THE NEWHAM (DOCK ROAD) (LOADING BAY) (NO. 1) ORDER 2011

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Newham on 3 May 2011 made the above mentioned Orders under Sections 6 and 124 of, and Parts III and IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders will be to:

- (a) introduce waiting and loading restrictions in the streets and lengths of streets set out in the Schedule to this Notice;
- (b) introduce a second disabled persons' parking bay adjacent to the existing disabled persons' parking place on the north-east side of North Woolwich Road;
- (c) introduce a loading bay on the north-east side of Dock Road approximately 60 metres south-east of Waterfront Studios.

3. Copies of the Orders, which will come into force on 9 May 2011, and other documents giving detailed particulars of the Orders are available for inspection during normal office hours on Monday to Friday inclusive at Reception, East Ham Town Hall, East Ham, London E6 2RP.

4. If any person wishes to question the validity of any of the Orders or of any of their provisions on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984 or that any requirement of the Act or any instrument made under the Act has not been complied with, that person may, within six weeks from the date on which the Orders were made, apply for the purpose to the High Court.

#### SCHEDULE

**Dock Road** - waiting restrictions operative "at any time" at the following locations:

(a) the north-east side

- (i) between the south-eastern kerb-line of Scarab Close and a point 86 metres south-east of that kerb-line;
- (ii) between a point 113 metres south-east of the south-eastern kerb-line of Scarab Close and a point 141 metres south-east of that kerb-line;
