1. NOTICE IS HEREBY GIVEN that Croydon Council on 31 May 2011 made the above-mentioned Traffic Orders under the relevant Sections of the Road Traffic Regulation Act 1984, as amended by the Traffic Management Act 2004 and all other enabling powers.

2. The general effect of the Orders would be to:-

(a) **introduce 4 limited time free parking bays in Brigstock Road as specified in Schedule 1 to this Notice which would operate between 9am and 5pm on Monday to Saturday inclusive and would be limited to a 30 minute maximum stay with no return to the same parking place within 1 hour;**

(b) **convert an advisory ambulance bay outside No. 88 Mayfield Road, South Croydon into a Neighbourhood Care Concessionary Bay; the parking place would be in operation 'At any time' throughout the week and the use of the parking place will be restricted to passenger vehicles for which a Neighbourhood Care concessionary permit has been issued by the Council;**

(c) **designate 2 Doctors bays in Edridge Road, Croydon as specified in Schedule 2 to this Notice for use by legally qualified medical practitioners only displaying a valid permit issued by the Council at a cost of £370 per annum; the bays would operate between 8am and 8pm, Monday to Sunday inclusive.**

3. Copies of the Orders which will come into operation on 6 June 2011 and of all associated Orders can be inspected during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Order was made, at the "Access Croydon" Facility, Taberner House, Park Lane, Croydon, Surrey.

4. Copies of the Orders may be obtained from Parking Services, Community Services Department, P.O. Box 1462, Croydon, CR9 1WX.

5. Any person desiring to question the validity of the Orders or of any provision contained therein on the ground that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
