

His Majesty's Conge d'Elire has passed the Great Seal, for Electing to the Bishoprick of Norwich the Reverend Dr. Thomas Green.

Whitehall, Aug. 25, 1721.

Whereas on the 27th of April last, James Herbert, of King'sry, Esq; late Knight of the Shire for the County of Oxford, was by a Pond at Waldridge, in the Parish of Dymton, in the County of Bucks, found dead; and, from many Circumstances lately discovered, was supposed to be strangled, and his Body brought and laid where the same was found; and whereas humble Application hath been made to His Majesty, by his Widow, to offer a Pardon to any one Person who shall first discover the Person or Persons guilty of the Murder of the said James Herbert, so as they, or any of them, may be brought to condign Punishment: His Majesty being desirous to have a Discovery of so horrid a Fact, doth promise a Pardon to the first Person who shall make Discovery of such Person or Persons who have been concerned in the said Murder, so as he or they may be convicted and brought to Punishment for the same.
