South-Sea-House, Aug. 30, 1721.

And that whereas by another Act for Restraining the said late Directors, &c. from going out of this Kingdom, it was enacted, That any Person before the 29th of September next, voluntarily coming before one of the Barons of the Exchequer, on an Oath in Writing upon Oath any Part of the Estate of the late Directors and others not inventoried, should be allowed 20 per Cent. if beyond Sea, and 10 per Cent. if within the Kingdom. It is by the said first mentioned Act enacted, that any Person in like manner voluntarily discovering before the 25th of March 1723, any such Estate not inventoried, shall have a further Allowance of 10 per Cent. And the said Trustees do hereby give Notice, that their publick Office is now kept at the South-Sea-House in Broad-street; and that on Wednesday the 6th of September, they will receive Proposals from Persons willing to supply them with Stationary Wares.
