1. NOTICE IS HEREBY GIVEN that Westminster City Council on 19th October 2011 made the above Orders under sections 6, 45, 46, 49, 84 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders, in connection with the Exhibition Road "Shared Space" Project, will be to:

(a) amend all the existing parking provision in Exhibition Road to be residents' parking only and to operate all day;

(b) introduce residents' parking bays (52 spaces perpendicular to the traffic flow) in the centre of Exhibition Road, between its junction with Prince Consort Road and Imperial College Road;

(c) adjust the kerb side parking in Exhibition Road between Prince Consort Road and Kensington Road in accordance with the new streetscape;

(d) amend existing waiting restrictions to be "at any time" and remove the existing loading restrictions throughout Exhibition Road;

(e) remove the right turn bans into Exhibition Road from Prince Consort Road and the northern arm of Prince's Gardens;

(f) adjust existing diplomatic bays in accordance with the new streetscape. Please note that the diplomatic bay in Exhibition Road, adjacent to No. 31 Prince's Gate will be extended from 6 metres to 8 metres; and

(g) introduce a maximum speed limit of 20 mph in Exhibition Road and the southern arm of Prince's Gardens, and in lengths of Prince Consort Road, the northern arm of Prince's Gardens and Prince's Gate Mews at their junctions with Exhibition Road.

Note: The references to Exhibition Road and Prince's Gate Mews refer to those lengths that lie within the City of Westminster.

3. The Orders, which will come into force on 24th October 2011, and other documents giving more detailed particulars of the Orders are available for inspection until the 30th November 2011 between 9 a.m. and 5 p.m. on Mondays to Fridays inclusive at West One, 10th Floor, Westminster City Hall, 64 Victoria Street, London, SW1E 6QP.

4. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Orders may, within six weeks from the date on which the Orders were made, make application for the purpose to the High Court.
