### THE CITY OF WESTMINSTER (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. \*) ORDER 201\*

- 1. NOTICE IS HEREBY GIVEN that Westminster City Council proposes to make the above Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Orders would be to revise the layout of parking facilities in Warwick Avenue as follows:
- (a) 16 shared-use parking bays would be located on the north-east side of the median opposite Nos. 32 to 38 Warwick Avenue;
- (b) 12 taxi rank parking bays and four shared-use parking bays would be located on the south-west side of the median opposite Nos. 21 to 27 Warwick Avenue; and
- (c) 11 pay-by-phone parking bays would be located on the south-west side of the median opposite Nos. 13 to 17 Warwick Avenue.

The proposals would result in an overall loss of four taxi rank bays and five pay-by-phone bays, and a gain of 9 shared use bays.
