2. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Hackney propose to make the above-mentioned Orders the Road Traffic Regulation Act 1984 as amended.

The general effect of the Orders would be to introduce a 20pmh speed limit on Evering Road (Manse Road – Rectory Road), Darville Road (full extent), Bayston Road (full extent), Leswin Road (full extent), Glading Terrace (full extent), Batley Place (full extent), Leswin Place (full extent), Batley Road (full extent), Hollar Road (full extent), Tyssen Road (full extent), Brooke Road (Stoke Newington High Street – Rectory Road), Lawrence Buildings (full extent), Sandford Terrace (full extent), Garnham Street (full extent), Sandford Terrace (full extent), Garnham Close (full extent), Smalley Close (full extent) and Cottage Walk (full extent).

Road Hump: The sinusoidal road humps will be constructed and maintained with a maximum height of 100 millimetres and will be 3.75m in length and vary in width. The on/off ramps will be constructed at a gradient of 1:10 to 1:20

The general effect of the Orders would be to introduce amendments to the waiting restrictions in Richmond Road in the vicinity of Navarino Road, together with the repositioning of the Zebra Crossing 4. Zebra Crossing is to be repositioned in conjunction with the raised speed table as described in the Schedule 1. The centre of the crossing will be 6m east of the junction with Navarino Road with an overall width of 2.8m with variable lengths of zigzag marking to accommodate bus stops and parking bays on the exits.
