### FUNCTIONAL ON-STREET PARKING REVIEW – SOUTH-EAST QUARTER

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London propose to make orders under sections 6 and 45 of the Road Traffic Regulation Act 1984.

The effect of the orders would be to increase in size Pay and Display and Disabled person's parking bays in certain streets in the City. In certain cases it would be necessary to remove and relocate individual parking bays. The streets affected are listed in the Schedule below.

## London Borough of Lewisham ROAD TRAFFIC REGULATION ACT 1984 THE LEWISHAM (PROHIBITION OF STOPPING OUTSIDE SCHOOLS) (AMENDMENT NO. 11) TRAFFIC ORDER 2012

NOTICE IS HEREBY GIVEN that Lewisham Council made this order under the provisions of section 6 of the Road Traffic Regulation Act 1984 on the 24 February 2012. The order comes into force on the 12 March 2012.

1. The general nature and effect of the order is, by amendment to its parent order, the Lewisham (Prohibition of Stopping Outside Schools) (No. 1) Traffic Order 1994, to-

(a) add a new length of yellow zig-zag no stopping markings outside the refurbished Brockley Primary School at Dalrymple Road southwest side from approx. 33 metres northwest of Brockley Road northwestward for 40 metres; and

(b) altering the northernmost length of yellow zig-zag no stopping markings outside the refurbished Gordonbrock Primary school at Gordonbrock Road west side to now run from 25 metres south of Brockley Grove southward for 40 metres;

prohibiting any vehicle from stopping on Mondays to Fridays from 8 to 9.30 am. and from 2.30 to 4.30 pm. on the no stopping markings. 2. Exemptions from the restrictions include vehicles stopping to avoid an accident, ambulance, fire brigade and police vehicles in an emergency and anything done with the permission or at the direction

of a police constable in uniform. 3. Any person wishing to question the validity of the order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984 or that any requirement of that Act or of any instrument or relevant regulation made under the Act has not been complied with may, within 6 weeks from the date on which the order was made, apply for the purpose to the High Court.

Dixon Road both sides between No. 7 Dixon Road and the A20 red route side road restrictions off Lewisham Way; and

St. James's both sides between No. 17 St. James's and the A2 red route side road restrictions off New Cross Road;

for only the 8 week period from the 16 July until the 9 September 2012 when it would cease to have effect.

THE GREENWICH (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. \*) ORDER 2012

### THE GREENWICH (BUS STOP CLEARWAY) (AMENDMENT NO. \*) TRAFFIC ORDER 2012

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Greenwich proposes to make the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:

(a) introduce single yellow line waiting restrictions that would operate between 10:00 a.m. and noon on Mondays to Fridays inclusive on both sides of Bexley Road between its junction with Eltham High Street and the boundary with the London Borough of Bexley, except in those lengths of Bexley Road where waiting restrictions or bus stop clearways already apply;

(b) revise the definitions of existing bus stop clearways in Bexley Road to accurately reflect their on-street situations; and

(c) formalise the existing waiting restrictions in Riefield Road between the common boundary of Nos. 60 and 62 Riefield Road and the junction with Bexley Road.
