## Road Traffic Acts

### Highways Agency

ROAD TRAFFIC REGULATION ACT 1984

THE A38 TRUNK ROAD (DOBWALLS BYPASS, CORNWALL) (24 HOURS CLEARWAY) ORDER

The Secretary of State for Transport gives notice that she intends to make an order under Sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984 on the A38 Trunk Road at Dobwalls in Cornwall. The effect of the Clearway Order would be to prohibit vehicles from waiting, at any time, (except in laybys) on any part of the carriageway, verge or slip roads of the A38 from the north-eastern edge of Twelvewoods Roundabout junction with the A390 Trunk Road to a point 912 metres east of the centre of Looe Mills Junction overbridge. It will reflect the changes to the A38 due to the construction of the Dobwalls Bypass and the slip roads at Petersfield Junction and Looe Mills Junction.

A38 TRUNK ROAD (DOBWALLS TO TRERULEFOOT ROUNDABOUT) (PROHIBITION OF WAITING) (CLEARWAYS) ORDER 1978 (VARIATION) ORDER 2009 (REVOCATION) ORDER

The Secretary of State for Transport gives notice that she proposes to make an Order under sections 1(1) and 2(1) and 2(2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984 on the A38 Trunk Road ("A38") in Cornwall.

The effect of the Order would be to revoke the London - Penzance Trunk Road (A38) (Dobwalls to Trerulefoot Roundabout) (Prohibition of Waiting) (Clearways) Order 1978 (Variation) Order 2009. This variation Order included a section of de-trunked carriageway in error. A replacement clearway Order will be made simultaneously with this revocation Order to ensure the continuity of the waiting prohibition.
