THE EALING (FREE PARKING PLACES) (NO. 2) (AMENDMENT NO. 169) ORDER 2012

THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. 500) ORDER 2012

THE EALING (PROHIBITION OF STOPPING OUTSIDE SCHOOLS) (AMENDMENT NO. 23) TRAFFIC ORDER 2012

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing on the 15th March 2012 made the above mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Parking Places Order will be to provide parking places for vehicles to park without restriction:

(a) with two wheels on the footway in Dormer's Wells Lane (i) on the east side opposite Nos. 39 to 77 and outside Nos. 114/116, 116/118, 120/122, 124/126, 128/130, 132/134, 136/138, 140/142 and 144/146 and (ii) on the west side outside 119a, 121/123, 125/127, 129, 131/133 and 135/137

(b) with all wheels on the footway in Dormer's Wells Lane on the main road side of the island site opposites Nos. 53 to 67 Dormer's Wells Lane

(c) on the carriageway of Dormer's Wells Lane on the west side outside Nos. 143 and 145 and outside Nos. 1 to 9 Mount Pleasant Cottages.

3. The general effect of the Waiting Restriction Order will be

(a) to introduce double yellow line waiting restrictions or change existing restrictions to apply at any time in the lengths of roads specified in Schedule 1 to this Notice;

(b) to introduce waiting restrictions applying between 8 am and 6.30 pm on Mondays to Saturdays in the lengths of road specified in Schedule 2 to this Notice.

4. The general effect of the Prohibition of stopping outside schools Order will be to relocate the school keep clear markings outside the entrance to Dormer's Wells High School in Dormer's Wells Lane opposite Greenfields.

5. The Orders, which will come into operation on 26th March 2012, other documents giving more detailed particulars of the Orders, are available for inspection at Customer Services Reception, Perceval House, 14-16 Uxbridge Road W5 2HL between 9:00am and 4:45pm on Monday to Friday, until the 3rd May 2012.

6. If any person wishes to question the validity of any of the Orders or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within six weeks from the date on which the Orders are made, apply for the purpose to the High Court.

Allenby Road, Southall
the east side, between the northern kerb-line of Dormer's Wells Lane and a point 5.4 metres south of the common boundary of Nos. 2 and 4 Allenby Road.

Burns Avenue, Southall

(a) the north side, between the western kerb-line of Dormer's Wells Lane and a point 18.0 metres west of that kerb-line;

(b) the south side, between the western kerb-line of Dormer's Wells Lane and a point 14.4 metres west of that kerb-line.

Dormer's Wells Lane, Southall

(a) the east and north-east side

(i) between a point 10.9 metres south of the southern side of the footpath leading to Greenford Road and a point 4.2 metres north of the southern side of the footpath leading to Greenford Road;
