### Road Traffic Acts

#### *Heathrow Airport Limited*

##### HEATHROW AIRPORT (CAMBORNE CRESCENT) ORDER 2012

1. NOTICE IS HEREBY GIVEN that Heathrow Airport Limited intends to make the above Order under Sections 6 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers in order to facilitate the management of traffic at Heathrow Airport.

2. The general effect of the Order will be to:

- Close Camborne Crescent for its entire length and remove it from the Heathrow Airport (Prescribed Routes) No1 Order 2011.
- Remove Camborne Crescent from the Heathrow Airport (Waiting and Loading) No1 Order 2011.

3. The Order shall have effect from 9 May 2012.

4. A copy of these Orders may be inspected by appointment during normal office hours, Monday to Friday, at Mott MacDonald, Stoneham Place, Stoneham Lane, Southampton, Hampshire SO50 9NW (telephone 023 8062 8751).

5. All objections and other representations relating to any of the Orders must be made in writing and must specify the grounds on which they are made and reach the address given in 4 above by 9 May 2012.

##### HEATHROW AIRPORT (CALSHOT ROAD & CONWAY ROAD) TEMPORARY ORDER 2012

1. Notice is hereby given that Heathrow Airport Limited has made the above Order under Sections 6, 14 and 16 of the Road Traffic Regulation Act 1984 (as amended), and all other enabling powers, to enable maintenance works to be carried out at Heathrow Airport Terminal 1.

2. The Order came into effect from the 9th April 2012 and shall last until 31st December 2012. The effect of the Order is as described in the proposal notice published in the *London Gazette* dated 28th March 2012.

4. Any person wishing to question the validity of these Orders or of any provision contained therein, on the grounds that it is not within the powers of the relevant enabling Act or that a requirement of any such enabling Act or of any regulations made thereunder has not been complied with, may, within 6 weeks from the date on which the Order was made, make application to the High Court.
