HEATHROW AIRPORT (2012 OLYMPIC GAMES) TEMPORARY ORDER 2012

1. Notice is hereby given that Heathrow Airport Limited intends to make the above Order under Sections 6, 14 and 16 of the Road Traffic Regulation Act 1984 (as amended), and all other enabling powers, to enable management of traffic at Heathrow Airport.
2. The general effect of the Order will be to provide permit parking places and dedicated vehicle lanes for 2012 Olympic Games vehicles, on the airport terminal roads and forecourts. This Order includes the suspension of existing Permanent Orders and Bus Stop Clearways.
3. The Order shall have effect from the 1st July 2012 and shall last until 30th September 2012.
4. Exemptions from the restrictions include anything done with the permission or at the direction of a police constable in uniform.

THE BEXLEY (WAITING AND LOADING RESTRICTION) (AMENDMENT NO.27) TRAFFIC ORDER 2012

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley on 11th June 2012, made the above mentioned Order under sections 6, and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985.
2. The general effect of the Bexley (Waiting and Loading Restriction) (Amendment No.27) Traffic Order 2012 would be to further amend the Bexley (Waiting and Loading Restriction) Order 2009 to:—
 - (a) Extend existing waiting restrictions (8:00 am – 6:30 pm, Mondays to Saturday) in part of Welling Way, Welling;
 - (b) introduce waiting restrictions ('At any time') in parts of Welling Way, Welling; and
