Paris, Jan. 3. The Misunderstanding between the Prince and Princess of Contr is said to be made up: The former, who had been indisposed for some Days, is very well recovered, and has since been at the Palace of Luxembourg to see his Princess, in the Presence of her Grandmother the Princess Dowager of Bourbon. The Cardinal de Rohan is expected here the 9th or 10th Instant. The Duke Regent has deferred the

Nomination to the vacant Benefices till his Arrival. It is said that Cardinal has refused a-new the Archbishoprick of Rheims which the Court offered him. On the 30th of December the Prince d'Elboeuf, and the Chevalier de Saintot Introdutor of Ambassadors, went in the King's Coach to the Hôtel of Ambassadors Extraordinary, there to receive the Duke d'Osuna Ambassador Extraordinary of the King of Spain, and carry him to his publick Audience of Leave of his Majesty. In his Passage the French and Swiss Guards stood drawn up under Arms: At the Foot of the great Staircase he was received by the Marquis de Dreux Great Master of the Ceremonies, the Hundred Swiss standing on the Stairs and in their Hall with their Halbards in their Hands. Within the Hall of the Life Guards he was received by the Duke de Harcourt Captain of one of the Troops of those Guards. After his Audience he was re-conducted to his Hôtel by the Chevalier de Saintot, with the usual Ceremonies. On the 1st Instant the said Spanish Ambassador had his publick Audience of Leave of the Duke Regent and of the Duke of Chartres.

Whitehall, Dec. 30. On Christmas-Day His Majesty with the Prince and Princess and some of the Nobility received the Holy Sacrament in the Royal Chapel at St. James's, the Communion-Office being performed by the Right Reverend the Lord Bishop of Lincoln Dean of the Chapel, and the Sermon preached by the Right Reverend the Lord Bishop of Gloucester.
