line waiting restrictions that would operate between 9am and 6.30pm on Mondays to Saturdays inclusive;

(i) in Prince John Road to introduce double yellow line 'at any time' waiting restrictions on:

(i)the north-west side, between the north-eastern kerb-line of Eltham Hill and 12.6 metres north-east of that kerb-line; and

(ii) the south-east side, between the north-eastern kerb-line of Eltham Hill and 10 metres north-east of that kerb-line;

(j) in Roan Street to remove 3.9 metres of existing shared use residents' and business permit parking place on the south-east side and replace with equivalent lengths of double yellow line 'at any time' waiting restrictions:
