Nos. 2 and 80/82. The parking place would operate Monday to Sunday 8.00am to 10.00pm and would be for use by Permit Holders only

- 4. The general effect of the shared use parking places order will be to amend the designation of a shared use parking place outside No. 68 Ranelagh Road E6, within Market Street Controlled Parking Zone, to take account of the designation of a new Disabled Resident Permit Holder parking place.
