(iii) the sale or offer for sale of goods from a vehicle will be prohibited unless there is in force a valid licence issued by the Brent Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(iv) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, will be prohibited;

- (v) any existing restrictions in the lengths of streets referred to in subparagraph (i) above will be revoked;
- (B) "Muharram and Ramadan Parking Places" Order will be to revoke the Brent (Muharram and Ramadan) (Parking Places) (No. 1) Order 2009 and re-apply its provisions with amendments so that, during the Islamic periods of Muharram and Ramadan:
- (i) a certain parking place in Chevening Road, the south-east side from a point 11.00 metres north-east of Carlisle Road north-eastward for 18.00 metres were revoked;
- (ii) the hours of operation of the parking places in certain lengths of the streets specified in Schedule 5 to this Notice were changed so that they will operate between 8.30 a.m. and 10.00 p.m.
- 6. The prohibitions referred to in paragraph 5(A) (i) and (ii) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Blue Badge" will apply.

7. The prohibitions and requirements referred to in paragraph 5(B) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in respect of anything done in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

8. A copy of each of the Orders, which will come into operation on 8 April 2013, of maps of the relevant areas, of the relevant Orders of 1979, 2004 and 2009 (and of the Orders which have amended those Orders) can be inspected during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made at The One Stop Local Office, Brent House, 349-357 High Road, Wembley, Middx, HA9 6BZ.

9. Copies of the Order may be purchased from the address mentioned in paragraph 8 above.

10. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent on 25 March 2013 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Traffic Management Act 2004. 2. The general effect of the 'Parking Places Amendment' Order will
- (a) shorten in length an existing shared use parking place and modify it to partial footway parking in Temple Road at the location specified in Schedule 1 to this notice, to enable for the installation of a pedestrian crossing;
